#### President's Column . . . James Marek

#### A Question of Bylaws

The first time I remember hearing the term "bylaws", I was a young boy

sitting through a series of congregational meetings. It seemed to me then that if someone had a good idea or suggestion, it could be quickly quelled with a statement that began with "according to the by laws". Those that wielded this phrase

seemed to want to prevent change or at least slow it down.

I have since learned that my original opinion was ill informed and that the people were actually well intentioned. Especially since being involved in the Synodical Committee I have gained a tremendous respect for our Unity Constitution and Bylaws as

well as for those who have labored to create them. While I may not under-

stand the original intent of the authors in all cases or even agree with all that is in constitution and bylaws, I have come to understand that they articulate our purpose as well as provide a workable framework with which the purpose is to be ac-

complished. They are the necessary rules by which the Unity currently functions.

There is an ongoing discussion about our Unity Bylaws with good people on each side. The traditional view is that our Unity Bylaws are, by in large, appropriate for today's Unity

just as they were for vesterday's Unity. The alternative view is that the Unity bylaws are outdated, provide an obstacle to change and restrict growth and modern church management. Based on observation of and even participation in by laws discussions, I believe both sides agree that our constitution is biblically based and requires little if any change. My prayer is that we can use our agreement to solve the issues on which we do not agree as it relates to our constitution and bylaws. Regardless of how we may feel about the subject of the bylaws, as members of the Unity we agree to abide by them and follow the rules to amend them when necessary. For this reason, if not for any other reason, we should know what our constitution and bylaws say and work amicably with others to change them when necessary. Article IV Section B (6) of our constitution says:

bylaws at the beginning of the problem resolution process.

As with any constitution and bylaws, there are some dry parts in ours but there is also some wise and valuable direction within their contents. Our constitution and bylaws represent a common bond we share as Brethren because we have all agreed to follow them. They are not perfect, but they continue to exist as a tool to help us accomplish our purpose.

A bylaws committee is actively reviewing and studying the bylaws with the purpose of creating a list of suggested changes by the October Synodical Committee meeting to be held October 20 of this year. The intent of completing the work by October is to allow all members of the

Unity ample time to review and discuss the proposed changes prior to the Church Convention next July (2013) in Taylor. The Bylaws Committee is led by Rev. Tommy Tallas. The members of the committee are Rev. Whitney Amos, Marvin Chlapek, Rev. Nello Strickland, Peggy Hejl, Jean Davis, Rev. Dr. Jerry Terrell, Kent Laza, and Dawn Marie Baletka. I also sit in as an ex-officio capacity.

These people have volunteered their time and service to improve and update the documents on which our Unity was founded and operated for the past 100 years. If you believe change is needed in a specific area of the bylaws, please contact one of the committee members.

### Synodical Committee Meeting April 14, 2012 – 9:00 a.m. MINUTES

At 9:00 a.m. President James Marek called the Synodical committee meeting to order. He welcomed everyone and opened with a prayer. Pat & Mike from Christ Covenant Church in Lewisville joined with us by Skype. Jon Farrow handled the connection with Skype. Roll call was taken – 54 were in attendance.

Ben Kruse, ministerial student, read from John 21:15 and had a short devotional. Ben repeated the Unity motto, and ended in prayer. Unity prayer was read by James Marek.

The minutes from meeting of October 22, 2011, were read, and accepted as presented.

#### Announcements

James Marek announced that we have Unity History books for sale at \$10.00 each. Bro. Jim announced we also have Bro. Dan Marek's book

Christian Sisters Convention will be held April 28 at Snook Brethren Church.

Bro. Mark Sebek Ordination will be held April 22 at Bryan-College Station

Brethren Church.

The Mutual Aid Convention will be July 14 at the Dime Box Brethren Church.

Plan to allow time at the 2013 Unity Convention for ministers to report on spiritual health and happenings in their congregations.

Direction on Missionary Gift Funds to Foreign Missions and Hus School Food Account donations: The practice of giving missionaries monetary gifts is discouraged due to various reasons.

Jon Farrow announced July 8 the Kozaks from the Czech Republic will be at the Temple Brethren Church. Reminders will be sent out soon.

Kent Laza reported that the Woo's will be coming to Texas for a couple weeks (around July-Aug). Kent will be scheduling visits to churches with the Woo's.

#### Reports

ByLaws Committee Update: Bro. Tommy Tallas reported the committee will have bylaws ready to consider at the fall Synodical meeting. Also reported on the Ministers benefit program. Issues will be presented at the fall meeting, as well.

Hus School Anniversary Committee: Bro. Tommy reported at the last convention it was moved for this new board to appoint a committee. They want to start addressing this and start forming that committee. He is seeking people who would be willing to help. Jim Baletka has volunteered to chair this event. No one present volunteered to serve on this committee. This will be addressed again at the October Synodical meeting.

Foreign Mission/Missionary Report: Kent Laza reported above in announcements that the Woo's will be coming to Texas, and he is scheduling visits.

Action to fill vacancy on Home Missions Board: Steve Davis is in the process of submitting his resignation. Claren Kotrla is willing to serve. Motion was passed unanimously to appoint Claren Kotrla to the Home Mission Board.

Rosenberg Brethren Congregation Name Change Consideration: James introduced Mike Pruett from the Rosenberg Brethren church. Mr. Pruett said the name selected by the congregation is Community Christian Church. Discussion. After discussion, motion carried. Mike Pruett thanked the committee for this decision.

Cade Lake Update and Funding proposals: Bro. Jim gave an update on Cade Lake and In God's Hands Ministry. Bro. Jim led a Praise Prayer.

Ben Kruse, a member on the Home Missions Board, gave a report from the board. They will get together a Power Point presentation and go to the congregations and try to solicit funds for home mission's projects. This presentation is planned to be ready sometimes this year.

James drew attention to the report of Dewyan Weise. Everyone was asked to go back to their congregation to be active in Foreign and Home missions and continue to pray for our missionaries. We also need prayers to provide the resources that we need to support this outreach.

\$36,000 – amount to fund Cade Lake. Need action item to fund Cade Lake. James proposed to start a transition of funding from contingency to the Home Mission Board that could occur in 6-month increments. The

funding for Cade Lake ends April 30, 2012. The \$3,000 a month in original form was to pay Bro. Jim for whatever he needs, not as a salary. A motion was made to accept the transition plan. There was no discussion, and the motion died due to lack of a second.

After more discussion, a motion was made and seconded to have the work of the home and foreign mission budgets to come out of the contingency fund if they come up with a deficit. The motion was amended to have the work of the home and foreign mission budgets through this year (December 31, 2012), come out of the contingency fund if they come up with a deficit. This was seconded, and after discussion, passed unanimously.

Concerning the Funding of Cade Lake that expires in April, Motion was made to, effective May 1, have \$3,000 to become the responsibility of the home mission board and discuss again at next Synodical meeting. Motion was seconced and discussion was held. Amendment was made to the motion that effective January 1, 2013, the \$3,000 a month funding for Bro. Jim's salary and other needs for Cade

Lake be moved over from contingency to home missions. Following second and discussion, amendment to the motion passed.

Vote on the main motion passed.

Motion was made to have \$3000 per month funded from contingency fund for purpose of Bro. Jim's Cade Lake ministry from May 1-December 31, 2012. Passed unanimously. May 11December 31, 2012, \$3000 a month will be funded out of contingency. Effective Jan 1, 2013, funding will

come from the Home Missions budget, per them presenting a budget that can be approved at the next Synodical Committee meeting.

Election of Pastor to the Pastors Position: This position is elected at the convention. In 2011 this did not happen. Bylaws say that this body should now appoint this position, but it does not say how. The pastors eligible are all pastors, active or retired. James Marek submitted that we do this by a paper vote. This is something that has not been done before. The Synodical Committee's job is to fill the vacancy, which is a vital role in the Credentials Committee, provides comfort to pastors and a member of the PRC.

Motion was made and seconded for the Synodical Committee to appoint the pastor to the pastors by ballot vote. After discussion, motion passed. James asked everyone to pray about this matter; we prayed individually and James led the group in a prayer. 30 votes were cast. Dr. Larry Koslovsky was elected to the position by ballot vote.

Consideration of Active Pastors local membership status: James said the general rule has been that the ministers are members of the Unity and not the churches they are serving. He read the bylaw addressing this. Request came from Bryan-College Station Brethren church on behalf of Vanessa Mitchell, who was called to specialized ministry, not serving any one church. She is an active minister in the Unity. The bylaws do not address this situation specifically. Motion was made that Rev. Vanessa Mitchell become an active voting member of BCS. Point of order by Ruth Rolston - we can't change a bylaw. Motion was made and seconded to table the issue and refer to the Bylaws Committee. Motion passed unanimously.

Salary Recommendation for Breth-

ren Journal Editor/Business Manager: James reported that each of these positions are paid \$400 each month. Cathleen Schlechte assumed both roles in October 2011.

Motion was made and seconded to begin paying Cathleen both salaries (Editor and Business Manager, a total of \$800 for each month) from October 2011 to April 2012, and in the future \$800 each month. Discussion on the balance of *The Brethren Journal*. Over \$11,000 in the fund reported by Dorothy Kocian. Passed unanimously

Motion was made and seconded to increase the pay to \$1000 each month – \$500 for the editor and \$500 for Business Manager effective May 1, 2012. Passed unanimously

James led a prayer, and break for lunch was taken at noon.

The meeting continued at 12:40. James reported that Dawn Marie Baletka, Chair of the Pastoral Relations Committee, is working on planning a Minister's retreat. Report by Dawn: The retreat would last about 3 days; ideas may be emailed to Dawn. Having it at a resort is a possibility.

Motion was made and seconded to authorize the Executive Committee to figure out how to fund this retreat. Passed unanimously

Consideration of Ministerial Student status of Dave Love: David Love is no longer a member at Wall Brethren. Students need to be a member of the Brethren church. Pastor Linda Chandler reported that she has not had contact with him in about a year. Motion was made and seconded to suspend the status of David Love as a ministerial student. Motion passed unanimously. Discussion: Funds were given to David Love as a ministerial student in the amount of \$1,200.00. Pastor Linda asked that we forgive this amount as he was a student at that time. Discussion on paying back the money in cash or by service time. Motion was made and seconded to forgive the \$1,200 funds for the education of David Love. Motion passed unanimously

In Tlaxiaco, Alejandro, and Sayra lead a team of Mexican missionaries committed to reaching unreached groups of

There were seven missionary trainees in the class, but let me tell you about one, Tina. Like Ruth, she is Mixtec, but her family moved to Baja, California, when she was young in order to work in the fields there as harvesters and she never learned to speak her native tongue. Her next door neighbor, a missionary to this diaspora of indigenous people, brought her to Christ and discipled her right into missions. On a shortterm trip to Morocco, she heard God's distinct call, not to that part of the world, but back to her own people in southern Mexico. So here she is, asking God to use her to reach the unreached.

She has already been reaching out to her mother. Gradually, her mother has left behind her fear of evil spirits, learning to call on God for protection and guidance. She has stopped setting up an alter for the dead on the



Day of the Dead, stopped tying red ribbons around the limbs of her newly sprouted plants and newly hatched chickens to ward off the spirits. She is beginning to trust in Christ. So Tina knows this is a long road, teaching her people to trust in Christ. I am thrilled to be a part of Tina's journey; helping her think about how the Mixtecs can come to Christ, not as latinos, but as Mixtecs. Very few Mixtecos ever hear such a message of Good News because the dominant culture around them has little regard for their customs or language.

People all over the world knew about our 7.4 quake within minutes. Thankfully, it had little impact on our lives. Yet how long will it take the world to feel the impact of these Mexican missionaries...Tina, Ruth, Mariano, Josafat, Mauricio, Cruz, and Ivonne...who have committed to turning the world upside down, one indigenous church at a time?

Please pray for God's blessing on our up-coming mentoring trips: Robert will be traveling to Panama for two weeks at the end of April, visiting Einer and Girlesa, fellow missionaries, who live among the Wounnan people there. They want to explore organic forms of leadership training that suit this non-Western people group that they themselves can reproduce naturally. Then, at the end of May, I travel to Chile to teach the one-week church planting course again, this time for students of the School of Frontier Missions of YWAM.

#### From the Raiford's . . .

April 10, 2012

Greetings to all and hope you had a great Easter.

Our church here in the city has begun doing volunteer work in a local soup kitchen of sorts. The place is a boarding house, meal provider (Estancia) for people coming in from the many villages around the state who have family in the government-run hospital a couple of blocks away. It is a Catholic run organization and charges just 20 pesos, or about 2 dollars, per day for room and board, and three hot meals. During our first visit there we met a man named Mario, a mute. Mario is a very energetic guy who we thought worked at the



Estancia, but Mario is staying there after being deported from Arizona and dropped off in Oaxaca with no money and separated from his family and new daughter in Arizona. All Mario wanted was to get a job and return home. Through our unconventional communication, we agreed to see what we could do. I honestly was a little skeptical about getting a mute a job here in the city. Thankfully God doesn't respond to my skepticism, and a few days later I get a call from a friend, Samuel. He tells me about a potential job for Mario in a downtown restaurant. I agreed to pick Mario up and take him to the interview and be somewhat of a "translator". I pick up Mario, who had no idea about what was going on, and we head downtown. We find the restaurant and ask for the owner, and we tell her the situation. She asks almost immediately when can he start, and I was shocked. Mario says tomorrow and

we walked out just laughing. Mario was so ecstatic, and I was in shock at how easy it was. Also, I was blown away by God's goodness. I was humbled that our church could have such a real impact so soon.

The next week Eunice and I join a medical brigade going to the southern Mixe region. We were accompanying Jeff Simons, who works with the coffee growers in the area. The organization provides fair wages and some social services to the villages who participate. Eunice, along with another doctor, was able to see almost 200 patients in the three-day trip. The village is called Chimaltepec, and very few people speak Spanish. The people were very shy, but we were able to share the gospel in the village. Thursday evening at the small church gathering I was asked to preach, and I spoke on Abraham's blessing to

all nations, and that the story ends in Revelations with all tongues, tribes, and nations praising God. The Mixe of Chimaltepec can't be ashamed of their heritage or language, but know that God made them that way, on purpose. The village is very beautiful, but a long way away from the city. It took over 12 hours to travel there, eating dust the whole way. We hope our encouragement helps the spread of the gospel in that village and the others nearby.

Unfortunately, real life always comes crashing in. Just yesterday we received news that our friend, Karina, lost her baby. She is the daughter of one of the leaders in our church, and good friend, Manuel. The baby was having some complications, and during her last checkup the baby's heart stopped beating. Infant mortality is still extremely high here in Mexico. Our own experiences only count for a small fraction here in Oaxaca. Eunice and I are on the mission to educate mothers on nutrition, prenatal care, postnatal care, and on the birthing process. But this education only works if there is a relationship between doctor and patient, which is why we are moving to the village San Juan Juquila Mixes. We are all deeply saddened by what has happened, but it is a daily reality here in Oaxaca. We also know that the pain and heartache is only cured by Jesus Christ. Medical services only treat part of the person, Jesus makes the process complete. Please pray for the Rosas family and their tragedy. Also for Eunice, who, having experienced this loss herself, puts herself in harm's way to help women with the same experiences. We can only prevent so much pain, but our promise is that one day the pain will end; we will have peace, and heaven on earth. We are called to GO, so that you may COME LORD JESUS.

- 6. To have life in 3D, you need to let Jesus be your Forgiver, Leader, and Friend. Explain what it means for Jesus to be each.



### Bobbing for Apples - with a twist

**Object**: Collect all of the same colored apples **Supplies:** 1 bowl per team, 6 Red Apples, 6 Green Apples, 1 large opaque or clear tub, enough slime to fill the tub, towels, wet wipes

**Do**: Prepare the slime as directed and fill the clear tub. Hide all of the apples in the slime. During the game, contestants will compete with each other to find the apples that match their team's colors. Have the contestants use their hands instead of their mouth. For added challenge, blindfold the contestants. The team to find all of their apples in the slime first, wins the game.

For 3 gallons of slime:

6 large pkgs of Jello 10 lbs of flour water 1/2 bottle of baby shampoo 1/2 large bottle of green food coloring Mix the Jello powder and half a bag of flour and about 1 gallon of water with a large wisk. Mix well until most of the lumps are out. Add flour in 1/2 bag increments. You want to slowly add water to the remaining flour mixture in order to keep slime from being lumpy. You can add as much water as needed until the slime is the consistency you desire. Once the slime reaches the consistency you desire, add 1/2 a bottle of baby shampoo and food coloring.
