President's Column . . . James Marek Unity Finances - Where Does the Money Go?

At a Fall congregational meeting in my home congregation back in No-

vember, a number of questions were posed related to Unity Missions, Brethren Fund contributions and Unity finances in general. These were honest and fair questions and I was encouraged by the local interest in how Unity funds are collected and


utilized. This experience led me to think that it might be good to offer some additional information on Unity programs and how they are funded.

As a collection of Brethren Churches, we are joined together to work cooperatively in the work of the kingdom of God. The denominational purpose summarized in our Unity Constitution is "to share the Gospel of Christ, locally and worldwide, and to build up believers in faith and obedience." The Unity of the Brethren exists to work cooperatively towards this stated goal. While each congregation works locally to further the kingdom of God in their respective communities, Unity churches work

> collectively to support various common interests.

> Specific monetary support for a limited number of these common interests is collected and deposited into a central fund known as the Brethren Fund. Contributions to

from each local congregation based on each local congregation's communicant membership. The term "communicant" member is generally accepted to mean "active" member, although each local congregation has the authority to define what level of activity is necessary to be considered a communicant member. Each congregation in the Unity remits \$30 per communicant member per year to the Unity as a means of support of Unity programs. For example, if a local church has 100 communicant members, the

local church would be responsible to make a \$3,000 contribution to the Brethren Fund. These contributions are due annually and are sent to the Unity Financial Secretary. While the total Brethren Fund contribution is due annually, most Unity Churches remit their Brethren Fund contributions and other donations quarterly.

Our current Unity Bylaws instruct that the Brethren Fund is to be allocated as follows: 10% to the Administrative Fund; 10% as a subsidy to the *Brethren Journal*; 25% to the Hus School Encampment; 20% for Church Extension; 35% to the Contingency Fund.

These allocations can be changed as necessary, but only through a formal Bylaws amendment. Any amendment to the Unity Bylaws requires action by the Unity convention and subsequent ratification by at least two-thirds all of Unity churches.

Based on these current ratios, Brethren Fund contributions (\$30 per com-

municant member) are currently being allocated as follows:

\$3 to **Administrative Fund** (Used for equipment, supplies and food, officer travel, etc.)

\$3 to the *Brethren Journal* (given to *Brethren Journal* as subsidy for operating expenses);

\$7.50 to the **Hus School** (given to Hus School to assist in operating expenses);


\$6 to **Church Extension** (used to help plant and support new churches);

\$10.50 to **Contingency Fund** (to be used by Synodical Committee for Unity work);

\$30 Brethren Fund contribution for each communicant member. The Unity currently has approximately 1800 members; therefore, the Brethren Fund contributions produce an annual revenue of approximately \$54,000. Under the current Bylaws, this revenue is being allocated as follows.

\$ 5,400 – Administrative Fund

\$ 5,400 – Brethren Fund



\$13,500 – Hus School \$10,800 – Church Extension \$18,900 – Contingency \$54,000 – Total Annual Brethren Fund Revenue

Brethren Fund contributions are collected by the Unity Financial Secretary and disbursed quarterly by the Unity Treasurer.

The information below has been taken from the most recent Unity Fund Balance Report presented to the Synodical Committee at the most recent meeting held on October 25, 2012. All of the funds listed on the Funds Balance Report are actually held in just 2 bank accounts — a checking account and a savings account. While the funds listed below carry separate balances, they are commingled in these 2 bank accounts. It is the responsibility of the Unity Treasurer and Financial Secretary to maintain individual ledger account balances shown in the table below.

Brethren Fund Contributions *help* **support**

- *The Brethren Journal* (Brethren Fund contributions cover only a fraction of annual *Brethren Journal* operating expenses.)
- The Hus School Encampment (Brethren Fund contributions cover only a fraction of the annual Hus School operating expenses.)
- Church Extension (Recently utilized to purchase facilities and pay some of the initial operating expenses at Cade Lake.)

Brethren Fund Contributions DO NOT Support

- Home Missions (Solely supported by voluntary donations. 2013 budget is \$67,000.)
- Foreign Missions (Solely supported by voluntary donations. 2013 budget is \$67,000.)
- Bible Fund (Contributions to American Bible Society. Solely supported by voluntary donations.)
- Board of Christian Education (The Board of Christian Education was merged with the Sunday School Union and it was decided that these funds would be held by the Unity. There is no reoccurring revenue source for The Board of Christian Education.)
- Educational Ministries/State Youth Director – (Partially supported by The Board of Grants and Be-

quests, the remainder by voluntary donations.)

- Ministerial Student Fund (Solely supported by voluntary donations. This fund has recently been utilized to fund the educational expenses of Unity ministerial students. Three ministerial students completed their theological training and were ordained in 2012.)
- Ministers Retreat (No defined funding source historically funded through Contingency Fund.)
- Convention (Paid by local churches every 2 years based on convention representation.)
- Ministers Retirement (Assessment paid by local churches for local pastor.)
- Income Protection for Pastor (Assessment paid by local churches for local pastor.)

As a denomination, we collectively support several projects and missions – the majority through voluntary donations. With the increased activity in the area of missions, as well as the recent approval of the mission budgets, missions are emerging as a priority by virtue of the resources (we say) we are willing to commit to this purpose. The coming year will tell if our stewardship will measure up to our words. May God bless and multiply our efforts and use them to glorify Himself as He furthers His purpose in the Unity of the Brethren and around the world in 2013.

Fall Synodical Committee Meeting October 20, 2012 – 9:00 a.m. MINUTES

Call to order and opening prayer

President James Marek called the meeting to order and welcomed everyone. James opened with prayer. There were 39 people in attendance as follows: 13 Pastors and 13 lay members including all 7 Executive Committee members; 7 serving on other committees and 6 visitors.

Steve Davis, Ministerial Student, brought a message to challenge the leadership of the Brethren and to uplift everyone. He asked the question, "How strong is my commitment to God?" We should strive to make a total commitment to God, even to the point of death. Steve had readings from the Old and New Testaments, sang the song "Breathe" with a message to serve God and want to do that greater than you want to breathe.

The Unity Prayer was read by James. "Holy Spirit, as in the past you united different men and women and made them one, so bring us together in a oneness that celebrates our diversity of talent and ability. May our

personalities blend in a superb harmony, as, laying our egos aside, we learn to prefer one another and to delight in encouraging the gifts we see in others. Let there be no star temperament, no prima donna behavior among us, but a sense of ensemble, as we try to be as anonymous as possible so that you can shine through our efforts to the glory of Christ. And when all is done may we be in the wings and HE in the spotlight, taking center stage and receiving all the applause! Holy Spirit, you who are fully God and yet so anonymous, hide us that we may reveal Him. Amen."

Joe Emerson made motion to dispense of the reading of the minutes, which was seconded by Pastor Kay Polasek and approved. Dewyan Weise made motion to approve the reading of the minutes that were sent out by email and submitted in the *Brethren Journal*. Seconded by Bro. Mike Groseclose and approved.

Announcements

James reported that Rev. Charles Amos and Rev. Whitney Amos of the Granger church have submitted their resignations effective December 31, 2012.

Rev. Larry Zabcik of Temple Brethren submitted his resignation effective November 7, 2012.

James asked Bro. Joe Emerson to report on his work status. He was working for Hospice until June, when they closed their office where he was. He is now working for the State of Texas in the CPS office. He suggested for churches looking for an outreach tool, there are tools available to help. He is available for pulpit supply.

Grants and Bequests Financial Assistance provided to Good Shepherd Moravian. They had some problems with their church roof; a loan of \$10,000 was made for a 4-year term by the Grants and Bequests Board. They are paying on time and also additional amount to principal.

James announced a plan to allow time at the convention (July 18-20, 2013, at Taylor Brethren Church) for ministers to report on spiritual health and happenings in congregation – Article III E 5. He would like churches

to be able to present what they are doing. A suggestion is to have churches have a display (poster with pictures, etc.) or have the pastor give a report.

Direction on Missionary Gift Funds to Foreign Missions and Hus School Food Account donations: James reminded congregations to not send money to the missionaries individually – to send monies to the Unity Financial Secretary. Money for the Hus Encampment Food Account should be sent to Jim Baletka.

Dorothy Hinson reported the Raifords do not have a sending agency. Discussion.

Change to the attendance recording in official minutes. James reported that the people back at home should be able to know who is attending the meetings, and he suggested having the minutes include those absent and present. Motion was made and, after discussion, was passed.

Insurance update on property and liability at Cade Lake: James reported that the Executive Committee has secured insurance for the building and premises. This was paid out of Unity Home Missions for \$1,386.91.

Appointment of Claren Kotrla to Home Missions Board: James announced we would have to re-do some action that was taken at the

April 14, 2012, meeting. Motion was made and seconded to appoint Claren Kotrla to the Home Missions Board. Motion passed.

Nominating Committee Formation: James reported we need to start thinking about people for this committee. It needs to be formed by the end of this year.

Bro. Gordon Hejl was recognized for celebrating his 60th Jubilee Anniversary and Bro. Henry Beseda for celebrating 61 years.

Praise report for Joyce Baletka's new grandchild.

Dates of the Convention are July 18-20, 2013, at the Taylor Brethren Church.

Lightning struck a tree and knocked out the internet connection. The folks from Christ Covenant are not with us by Skype. Bro. Ron Winsman is currently visiting them in North Carolina and will be giving communion to them during worship. They have submitted a paper report (see Agenda 5-L). Bro. Larry Koslovsky has also visited with them.

James announced that the Czech Heritage Society was looking for an old Brethren church to put on their grounds. Harvey Treybig spoke about this to the committee.

Bro. Joe Emerson announced that Brighter Vision, a mixed trio, will have a 1-hour presentation called "A Night of Hope". Dates available are November 25 through December 20.

Reports

Minister's Retreat Report: James reported that 18 ministers and their wives attended the retreat at Horseshoe Bay. It was received very well and programming was a good mixture of time of togetherness and time to be on your own. Bro. Joseph Polasek commented that some of the pastors talked before they left the retreat and agreed to try to meet every 2 years or so. Dawn Marie Baletka was thanked for all her hard work and planning with the retreat.

Bylaws Committee Report (to include response to issue of pastor role in local polity): Bro. Tommy came forward to give his report. A paper report was also given (Agenda 7) He has been working on the Unity Bylaws with his committee. It has been a lot of work. He wants everyone to secure a copy of the 2009 Bylaws. We can address this at the Convention in

July or have a special convention. He believes that with homework ahead of time we could address this at the Convention. He would make this update available to everyone – by email or hard copies, so everyone could compare the updates with the old copy.

There were questions and discussion on how this could be done. If it does not get handled at regular convention, it would go to a special convention. Motion was made to have the Bylaw Committee have all changes by February 1, 2013, and have a document ready so churches can meet in March for questions at the April Synodical Committee meeting. The Bylaw updates could also be posted on the Unity website in a PDF file. Motion was passed.

James reported that the Bylaws Committee was also asked to include response to issues of pastor roles in local polity. Bro. Tommy reported this was discussed, and the committee believes that all ministers at the Unity level cannot hold office or vote at the local level. This did not come from Rev. Mitchell's request, but from the Bryan/C.S. Brethren Church.

Appointment of Hus School Anniversary Committee: Motion was made to have Jim Baletka serve as committee chair. During discussion, it was suggested to have the anniversary be held on a Saturday. Motion was accepted and passed.

Home Mission Board Appointment: Discussed in Announcements.

Consideration of Mission Budgets: Foreign Missions – Kent Laza, Chairman of the Board, came forward to give a report (Agenda 10-a). Kent reported that we are supporting 5 families: Rob & Anne Thiessen in Southern Mexico, Michael & Caroline Woo in Southeast Asia, Phil & Eunice Raiford in Southern Mexico, Pavel & Stan Kozak in Moravia, Czech Republic, and Carolyn Groseclose in Central Africa.

The proposed budget for 2013 is \$56,400. It is reduced by \$10,600 (16%) from 2012. There was discussion on how long we have supported some of the missionaries. Thanks were given to the Foreign Mission Board and to Joyce Baletka for all the work that was done for the Woo's when they visited this summer in Texas.

Home Missions: Bro Jim Heckman reported on activities at Cade Lake. Claren Kotrla, reporting for Rev. David Johnson, Chairman of the Home Mission Board, came forward to present the proposed 2013 Home Missions budget. Most of the work of the Home Mission Board is with the Cade Lake Community Church. The youth held a fish fry to put up a new sign for the entry to the subdivision – \$500 was raised for the sign. Other activities are included in the report submitted by Bro. Jim.

James asked at this time for Dewyan Weise to come forward and report on the Unity Fund Balance Report. Dewyan pointed out a few items of expenses that we are going to have to meet that will come out of the contingency fund such as the Ministers Retreat (\$18,238.50) and Ministerial Student (\$14,376.66). There was discussion on the funds and income.

James asked Marvin Chlapek to come forward and give a little information from the Financial Secretary Report. Marvin reported that in 2008, before there were 2 mission boards, \$78,200 was given total. In 2010, when we split the two into Foreign and Home it was \$48,200 for Foreign, \$19,000 for Home missions.

James asked for respectful discussion on these items – ideas on how the Unity wants to proceed, funding mechanisms and other discussion. There was discussion. James gave a prayer. There was lengthy discussion.

A motion was made that the 2013 budget for foreign missions be set at \$67,000, and the board would revaluate the budget in 2013 and give the missionaries 6 months' notice should the budget be cut, and if there are any deficiencies, fund those through the contingency fund. After discussion, the motion was accepted.

Bro. Tommy made a motion that both foreign missions and home missions be directed to publicize their budget for 2013 and to undergo fundraising efforts to meet their budget. The motion was discussed and then amended to add "by joint venture". After additional discussion, the amended motion passed. The amended motion to read: For both foreign missions and home missions be directed to publicize their budget for 2013 and to undergo by joint venture fundraising

efforts to meet their budget.

Discussion on the budgets of Foreign and Home missions: Motion was made to set the 2013 Home Mission budget at \$67,000, and any amount not met of that budget would come from the contingency fund. It was seconded and discussed, then passed.

Bro. Tommy reported that the convention is a good opportunity to seek funding for missions. Kent Laza thanked the committee for their support.

Claren reported that the Cade Lake presentation is now ready and will be presented in churches.

James feels confident that we can move forward and know that God will bless us in this effort. He thanked the committee.

There was discussion on the remuneration for supply pastors for Rev. Jim Heckman. Paying for supply pastors is addressed in the PRC Salary and Guidelines booklet. Motion was made for the Unity to pay supply Pastors at Cade Lake \$100 for those not ordained and \$150 for those ordained, and pay 25 cents a mile. Motion was seconded, discussed, and passed.

Industry/Fayetteville Brethren Church Honor Our Veterans Service

Industry and Fayetteville Brethren Churches honored 115 veterans on Sunday, November 11, 2012, at the Industry Brethren Church 9 a.m. service. This was the 3rd annual service of this kind for Industry Brethren Church and the first combined Industry/Fayetteville Brethren Church service.

Sharon Spiess, Yvonne and Russell Wait sang "Onward Christian Sol-

diers" as two men carried in a religious military banner that reflected the different branches of the military and a cross that soldiers are looking at. The scouts led the march as the banner was presented. It was hung at the front of the church to set the mood of the event. The scouts also led the Pledge of Allegiance as the audience joined in. Lynn Davis sang "God Bless the USA" and "The Star Spangled Banner".

The service message was delivered by Pastor Kay Polasek. Chord organ music by Liz Ripple of the Fayetteville Brethren Church and organ music by Sharon Spiess were provided for accompaniment to the singing and during the calling of the honored veteran's names. The church bell rang one time as each veteran's name was called. The congregation sang "My Country 'Tis of Thee" and "O Beautiful for Spacious Skies".

The church was decorated with many flags, including all the flags of the different branches of the military. A large flag draped on a tripod was in

the front of the church where a large flag bow held red streamer ribbons containing name labels of each honored veteran. All branches of the service were represented in this group of veterans and all times of service dating back to the Civil War and current active service. People enjoyed viewing all the biographies of these men and women who served our country.

Prayer...The Bible talks a lot about prayer. There is also a model for us to follow when we pray. Teaching our children to pray is an important job that we must diligently tend to at all times. For children, talking to God, who they cannot see, may seem overwhelming. They may feel like they don't know what to say. This month's ideas will provide some guidelines for children as they develop a lifetime habit of prayer.

Children

Lesson:

- Explain to children that Jesus taught His disciples to pray. We find that lesson in the Bible – it's the Lord's Prayer.
- Remind children that God always hears our prayers, but sometimes His answers are not what we were expecting. We must trust God and know that His answer is what is best.

Prayer for Teens: The Purpose of Prayer


Ask teens to brainstorm the purpose of prayer – why do we pray? Discuss the reasons listed.
