President's Column . . . James Marek Report to the Synodical Committee

Wow! It is hard to believe these

past 2 years have passed so quickly and that the 65th Biennial Convention is just around the corner. Throughout these 2 years, I have had a chance to work with many good people around the Unity, and I am grateful for these opportunities.

I want to thank the members of the executive committee who have served with me over the past 2 years. The members of the Synodical Executive Committee are Rev. Lawrence Junek, Rev Jimmy Heil, Rev. Tommy Tallas, Liz Ripple, Marvin Chlapek, and Dewvan Weise. I am truly grateful for the opportunity to have served with these fine people. We regret that Bro. Jimmy, Bro. Tommy, and Marvin have decided not to continue on the executive board at the conclusion of their current terms, but we thank them for their service for the past 2 years.

The plans for the 65th Biennial

Convention to be held on July 18-20 in Taylor are being finalized. The Theme for this year's convention is "Faith in Action" taken from James 2:26 which says, "As the body without the spirit is dead, so faith without deeds is dead." My hope is that we will be able to

do some things at this convention that will be a little different. As in the past, a certain amount of time will be dedicated to the business of the Unity including the consideration of the Bylaw revisions but we are working to make this convention more than just business. Within these last 2 years, I have been encouraged and impressed with the ministry and outreach that is happening in and through several Brethren churches around the state. We want to share some of these outreach efforts with the convention attendees. Our hope is by sharing

some of the various ministries underway in other Brethren churches, we all will be inspired to try similar or even new ministries at our own congregations. I am convinced that God is at work in the Unity, and my hope is that through these congregational presentations we will get a glimpse of how He is working and how we may be able to join Him in His work. After hearing about some of these outreach efforts and ministries, I believe there is growth in the Unity. The kind of growth that matters – spiritual growth and maturity. I encourage everyone to come to the convention and hear what is going on around the state. I think you will be encouraged and inspired, as well.

We are also making plans to offer a few presentations on the use of technology within the church and how it may be used to expand our ministry outside our communities as well as improve communication within our churches. Please pray for the convention that God will use this time to unify us and strengthen us in our faith and our ministries.

We rejoice with the Granger and Houston congregations as they welcome new full-time pastors. The Houston Brethren Church has recently called Rev. Dr. Jerry Terrill and Granger has called Rev. Larry Zabcik. Both ministers have accepted these calls and are now actively serving these congregations in a full-time capacity. We pray for God's blessing upon these new partnerships and look forward to seeing the good God has planned for each congregation.

According to our financial report as of the April Synodical Committee meeting, we are falling behind in our efforts to meet our Missions budgets. The financial report shows a negative balance in the Foreign Missions account. We are also behind in our support of the Home Missions budget. Please keep in mind that the Synodical Committee approved budgets in the amount of \$67,000 for the Home Mission Board and the Foreign Mission Board separately for a total Unity Mission Budget of \$134,000 at the synodical committee meeting last October. While this is the largest mission budget ever undertaken by the Unity, it is not impossible. The entire combined budget could be met if just 75 people around the Unity could commit to giving \$150 per month to missions. While we may not all be able to make this kind of monetary commitment, I believe there are at least 75 people out there who could. Please prayerfully consider what God is leading you to do in the way of this mission effort. May God be pleased with our faith and our stewardship in this important ministry.

The Board of Grants and Bequests has met since our last Synodical Committee Meeting. Roger Runnels has been elected as the organization's president and the board has begun a new effort to investigate ways to increase the board's activity and visibility with the Unity. By the time Convention comes, they hope to have new printed materials to publicize the organization and its work within the denomination.

As we look forward to Convention and beyond, my belief is that if the Unity is to grow – spiritually and in numbers, we must all seek to improve our personal relationship with Christ and allow Him to lead us to new ministries as local churches and as a denomination. For this to happen, I believe the first step to this is through increased knowledge of the scriptures. My prayer is for God to give us a hunger for the scriptures as a denomination so that we may be fully equipped and inspired for every good work as we serve our God and our fellow man. Please be praying that God will whet our appetite for His word and speak to us through it, that we may know His will and strengthen us to do it.



Credit Report

Mark 6:7-9 (NET) – "Jesus called the twelve together and began to send them out two by two. He gave them authority over the unclean spirits. He instructed them to take nothing for the journey except a staff – no bread, no bag, no money in their belts – and to put on sandals but not to wear two tunics."

Remember the year 2000?

Isn't it amazing that a year that once seemed so far in the distant future now lies buried in the somewhat distant past?

I certainly remember the volume of work it created for me as 1999 dawned and 2000, or Y2K as it was known, loomed ominously on the horizon.

Since 1994 the bulk of my work revolved around a series of annual reports published for one of our major clients. Everything from database structures to computer programs to report formats were built in-house from the ground up. When 1999 dawned, I knew that in one year this project would come to a screeching halt as everything we had put in place was

based on two digit years and the system would simply choke if we keyed the year "00".

Computers are quite literal and do not respond to human beings screaming, "You know what I mean!"

So, along with that year's normal workload (an extremely relative term), I put in a great deal of overtime copying, converting, and testing each and every data element to accept, process, and display four-digit years.

When 2000 arrived, everything was in place and actual processing began. There were a few minor bug fixes here and there, but for the most part everything worked as intended and the client received his final reports on time. He also received a larger bill to cover the additional work. Progress, after all, often comes with a price.

Later that year, I happened to read a news article which stated that the administration currently in office was taking a great deal of credit for the Y2K transition going as smoothly as it had.

The administration and I did not

quite see things the same way. In my opinion businesses had two options. They could either have invested the time, resources, and manpower required for it or they could have closed their doors on January 1, 2000. To be completely honest, I felt like someone else was taking credit for my work!

So, what does all this have to do with Jesus sending out the twelve?

The twelve were sent out and they would cast out unclean spirits. They could not do this by their own power. They could do this because He had given them the authority to do it. In fact, they would not be able to be self-reliant in any way.

Mark tells us that they took no bread, no money, not even an extra tunic to ward away the chilly night air. They would have to rely on God completely. They would have to rely on God to provide for their every need from food to shelter.

Today we find ourselves in a similar situation. Scripture tells us to preach the gospel to every creature (Mark 16:15). As we do, people will be saved.

However, the words we use are not truly our words. We must rely on Him to supply them. Those that are saved, we do not save. We must rely on Him to save them just as He saved us.

In the year 2000, I did not appreciate someone else taking the credit for my work.

I certainly will not be taking any credit for His.

- g. 100th Celebration of the Hus School class Reported by Jim Baletka dates are April 25, 26, 27, 2014. The planning date is April 27, 2013 at 2 p.m. at the camp. Anyone interested is invited to attend this meeting (attachment Agenda 3-g).
- 4. By-Laws Presentation and Discussion Process James reported that he received an email from Rev. Whitney Amos, who was not able to serve on the committee because of health issues and her children's schedules. James read the email from her. The committee members present came forward to take questions. James en-

couraged everyone to ask questions, to disagree with respect and in love. He asked everyone to take back to their congregations what you hear today. At convention, a certain amount of time will be devoted to By-Laws; if we don't get it all done, a special convention may be called.

Tommy expressed how grateful he is to all the members of the committee. We want to discuss the big issues, not typo's at this time. All comments are appreciated.

Discussion began: Bro. David Johnson had a question on putting the Chairman of the PRC on the Synodical Committee as a voting member – see Article VI. Synodical Committee, Sec A, 4 on page 24 of the strike-through edition. Discussion.

Bro. Tommy stated that when a committee (By-Laws) is representing a body, the report that comes from that committee comes as a motion. Dewyan stated that we could amend their document any way we choose or vote down the revisions separately.

MOTION – from the By-Laws committee to accept this document in its entirety as written.

SECOND – Bro. Lawrence Junek Discussion. If we vote this motion down, then we can go forward and pick it up and go forward with what we want in the document. Discussion.

For – none. Against – everyone. The motion fails. Discussion.

MOTION – by Pastor Kay Polasek to table this discussion as a whole and have a special convention just for by-laws to give the congregations more time to review the document.

SECOND: by Bro. Larry Butcher Discussion. James asked people to say their representation as they speak.

For - 4. Opposed -10. Motion is defeated.

Bro. Tommy wanted to know what to do with this specific area in the document regarding the Chairmen of PRC on the Synodical committee. Discussion.

MOTION: by Rev Linda Chandler to go with whatever is in the 2009 (current) by-laws; strike the provision that suggests the PRC Chairmen be a voting member of the Synodical committee which is Article VI. Synodical Committee, Sec A, 4 (on page 24 of the strike-through edition).

SECOND: by Rev Kay Polasek Discussion.

Opposed - 2. All others in favor. Motion passes.

Rev. Denise Mikeska, Seaton Brethren concerns on Article II, Congregations E-3 – page 8 of strike-through. Concerns with the striking-through of the "two-thirds of members". Question on how property is divided in case members withdraw from the Unity. James stated that all church property

belongs to that church, this was put in to try to strengthen the rights of those who remain loyal to the Unity in case a decision was made by the church to leave the Unity. Discussion. The committee was trying to strengthen this area. Discussion.

MOTION: by Bro Larry Butcher proposes to strike the proposed changes in Article II. Congregations, Sec. E-3 (on page 8 of strike-through edition) – basically go back to the 2009 by-laws.

SECOND: by Pastor Kay Polasek Discussion.

Opposed - 2. Everyone else in favor. Motion passes.

James gave a prayer for the meal. Session came back at 1:15 p.m. James made opening comments.

James had one announcement – the status of Pastors IRS situation; those that were using Guy Huffman's office – that is not changing. If any pastors need to make changes, you need to contact their office.

Question by Bro. Larry Koslovsky – why are some Pastors not going through the Unity with their W-2's if pastors are employees of the Unity? James answered that that's the way

we've done it. It was noted if congregations are doing it themselves, they are not in compliance with the Bylaws (Article III, E-2).

Discussion on By-Laws continued: Bro Larry Koslovsky – discussed 1-year and 5-year licenses; there is mention of a 5-year license in the 2007 by-laws but it is not in the 2009 bylaws. It's on page 16 of the 2007 bylaws. Bro Larry stated that changes, when they happen, are usually put in parenthesis. The committee will check on this.

Bro. Larry Junek – questions on Article III, Section B, 10 page 15 of the strike through edition – Bro. Tommy explained how the current Credentialing Committee is selected and their duties and how the current Examining Board is chosen and their duties. Proposed change is to make the Credentialing Committee an appointed position. Currently the Pastors serving on the Executive committee are the Credentialing committee. Comments. Discussion.

MOTION: by Pastor Kay that we strike Article III, Office of the Ministry Sec B, 10 (on page 15 of the strike-

SECOND: Bro. Larry Butcher

Discussion. If there are other parts in regards to the Credentialing Board in the strike-out, they would need to be adjusted. Discussion.

In favor -12. Opposed -8. Motion to delete this item passed.

Discussion continued on this section in the strike-through to have the convention elect the Credentialing Board.

MOTION: by Gayle Farrow to bring back the above Article III, Sec B, 10 and replace the wording "appointed by the President" to say "elected by the convention."

SECOND: by Bro Mike Groseclose Discussion.

In favor -15. Opposed -9. Motion passes as amended.

Dewyan had a question regarding the 2009 by-laws (page 35) Appendix A – Hus School Encampment, Article IV, Finances sec C that says "at the beginning of each calendar year." He reported that it is not being done this way. Discussion.

MOTION: by Dewyan to amend Appendix A, Article IV, C (page 40 of the strike-through edition) and strike the word "at" and replace with "on or before" and do the same in By-laws Article XIV., Sec F (page 33) – replace the word "annually" and replace with "on or before the beginning of the year."

SECOND: Bro. Mike Groseclose All in favor – almost everyone. Opposed - 1. Motion passes.

Bro. Tommy – Discussed the Brethren Fund percentages: In the strike-through edition, page 10 -

Article II, L-25% to the Hus School Encampment, 20% to the Brethren Journal, 10% for Administration Fund, 35% -Contingency Fund, 10% for Church Extension or some other worthy cause.

The executive committee suggests 2 changes to the above: to have 21% Contingency and 14% go to Educational Ministries. James – discussion to make this more transparent. Fund is called Educational Ministries, but the Youth director is paid out of

it as well as other things.

The Synodical Committee gave the Youth Director, Jennifer Chervenka, permission to speak. She questioned if the Collegiate ministry expenses would come out of Educational Ministries. Discussion – answer it could.

MOTION: by Bro Mike Groseclose to accept the breakdown of percentages to the contingency fund to say: 21% Contingency and 14% Educational Ministries.

SECOND: by Gayle Farrow

Discussion on what 2009 by-laws now say.

MOTION WITHDRAWN: by Bro Mike.

SECOND WITHDRAWN: by Gayle Farrow.

MOTION: by Dewyan to have the Brethren fund be allocated as: 25% to the Hus School Encampment, 20% to the Brethren Journal, 21% Contingency Fund, 14% Educational Ministries, 10% for Church Extension or some other worthy cause, 10% for Administration Fund.

SECOND: by Pastor Kay

Passes

Pastor Kay had questions on the Article III, Office of the ministry pages

11-20. Why so many strike-throughs? Explanation by Bro Tommy – Articles are re-arranged, content is still there. Discussion.

Bro. Larry Koslovsky – had a question on Tracks of study page 19 Article III-Office of the Ministry, Sec E – Requirements for Pastoral or Specialized Ministry, #9, a; he questioned "the preferred method of study for ordination", asked who says this is the preferred method. James gave an answer – the preferred method has historical value. More discussion. Should be careful about what schools are accredited Seminary and College. James explained that the Synodical committee still gets to give approval on this.

Bro. Larry Koslovsky – another question about licensing – what do we do with those folks who are now serving and have served in churches that may not have a college degree that may be serving with a license. James explained that these changes would be for those going forward; others would be "grandfathered." Bro Tommy – explained that we will not make this retro-active. Discussion.

Liz Ripple, Fayetteville, had a question on Article II - Congregations, G-Restructuring of Congregations, 2-a. Page 8 is being struck – "...congregation is served in conjunction with another congregation..." Question – is this a push for one church – one pastor? Discussion. Also questioned was the "Pastoral Salary Recommendations" distributed by the PRC. Marvin stated that salary guidelines are just that, guidelines.

Liz suggested to the By-laws Committee to add somewhere in this Article, maybe in Sec G – Restructuring of congregations – to reference "(see Article XXII – PRC, Sec. E – Pastoral and Parish Changes, 2 on page 31) – "Any change in parish arrangement shall have the final approval of the congregations involved." Bro. Tommy said they could do that, but #3 would

supersede any decision made by the church.

Pastor Kay questioned in Article XII-PRC, Sec A#1 (page 30) – where is how to elect the Pastor to the Pastors? Bro. Tommy explained – it is an oversight and was neglected to be carried over to the strike-through edition. It will be put back in Article XII, Sec A#1 to say "The Pastor to the Pastors shall be elected by the clergy during the course of the convention through a series of votes until one pastor receives the majority of votes."

Pastor Denise Mikeska had a question in the Constitution – Article VI – Organizations – Section D. – regarding the Brethren Youth Fellowship, what does "officially recognized" mean? Seaton has a Youth group that is not called the Brethren Youth Fellowship. Will their youth be recognized by the Unity if they are not using a certain name? James explained this is dealing with the denominations organizations and membership would be determined by their bylaws.

Discussion on Primetimers by Bro. Lawrence. He explained this is an event – a retreat – not an organization. He took the opportunity to invite everyone to attend – the second weekend in October.

Jim Baletka – Is there a need to have an article for the job description for the Pastor to the Pastors similar like we have for the Executive officers on the Synodical Committee? Discussion.

MOTION: by Pastor Kay on page 30, Article XII-PRC, Sec A, 1-d to unstrike this line, "The pastor shall be a member of the Pastoral Credentials Committee and serve as a pastor to all categories of pastors and students for the ministry" and revert back to the 2009 by-laws.

SECOND: by Bro. Mike Groseclose Passes

MOTION: by Pastor Kay in regards to Article XII-PRC, Sec A, 1-D (since this line is back in the document) to amend by adding after "pastor" the words "to the pastors".



Dear partners,

We are in need of prayer here. Many of you may follow what is happening in Burma/Myanmar. There have been many good changes in the country recently, but there are still tons of problems. One such problem has come knocking on our door.

We are about a 5-minute walk to the river that separates the two countries. Our kids like to swim in this river. This past week, further down the river on the Burmese side, maybe about 20 minutes down, Burmese soldiers came and have attacked the Dai/

Shan in a local town. The Burmese soldiers then came across the river onto our side of the river (as some parts of our side belong to Burma and not China). About 12 people have died.

There has been gun fire and fighting between the Shan/Dai state army and the Burmese soldiers. China has also sent soldiers out to the area. The local Dai are fleeing for their safety.

It is unclear why they have attacked. This area is really under the control of the Shan people, not the Burmese government, even though it is in Burma.

The Jingpo in this area have also been fighting the Burmese soldiers for around 2 years now as many of you have heard us talk about the refugees.

We ask you pray for peace. That the Prince of Peace Himself would come and reign! That the fighting would stop today. That the Burmese soldiers would leave the area immediately! That Jesus would say "Peace. Be still" to this storm as he said to the storm in Mark 4.

As for us, we feel completely safe as there is probably no way China would let the war come onto their land. China definitely is the stronger
