President's Column . . . James Marek What Lies Ahead for *The Brethren Journal*?

When Rev. Adolph Chlumsky first published the *Bratrske Listy*

more than 110 years ago, he did so primarily to facilitate and foster communication between individual Brethren Churches. The Bratrske Listy or Brethren Journal, as we know it today, has been an important communication

tool and the only official publication our denomination has ever had. It is actually older than the present Unity of the Brethren that exists today. *The Brethren Journal* has served the Unity well for many years, but has recently fallen on some challenging times.

In recent years, the admired publication has struggled to keep pace with its financial obligations. At the most recent Synodical Committee meeting, a \$7,000 loan was approved to meet the operational expenses through the end of the

year. This was the second operating loan provided to *The Brethren*

Journal in less than 6 years. Escalating printing costs coupled with declining circulation and advertising revenue have contributed to the current financial state of *The Brethren Journal*. Some have questioned whether *The Brethren*

Journal can continue in its current form and under the current financial model.

How It is Funded?

The Brethren Journal derives its support from subscription revenue, advertising revenue, the occasional donation, and a portion of the Brethren Fund (fee collected by the Unity from all Brethren Churches at the rate of \$30 per member per year). In recent years, 10% of the Brethren Fund has been directed to

the operation of *The Brethren Journal*. In an effort to improve the financial condition of *The Brethren Journal*, the 2013 Convention voted to increase the support from the Brethren Fund to 20%. While this move will certainly help, more will likely need to be done to ensure the continuation of *The Brethren Journal* – at least in its current form.

What Else is Being Done?

In addition to approving an operational loan, the Synodical Committee also approved an increase in The Brethren Journal subscription rate from \$12 to \$15. This was the first increase in the subscription rate since 2002, when the subscription rate went from \$10 to \$12. The Synodical Committee also instructed The Brethren Journal Business Committee to work with the new communications committee, authorized by the 2013 convention, to investigate ways to further increase revenue and decrease expenses. Once again, the idea of reducing or eliminating the commercial printing of The Brethren Journal was discussed. It was suggested that an electronic version of The Brethren Journal could be emailed to the local churches and the local churches would then be responsible for printing paper copies for members who did not have access to email or a computer. The assumption is that by reducing the costs associated with commercial printing, a significant portion of the total production cost could also reduced. A motion was passed that instructed *The Brethren* Journal Business Committee and the communications committee to investigate an electronic production option and any other scenarios that may be viable long-term solutions to the financial hardship of this treasured publication.

Is there Anything Else That Can Be Done?

Since serving on the Synodical Executive Committee, I have learned it is always a good idea to look at the bylaws when challenges, questions, or problems arise within the Unity. It may surprise some to learn that our current Unity Bylaws stress the need for an advocate for *The Brethren Journal* in each congregation. Article II Section (O)

says"The congregation shall elect a zealous agent for The Brethren Journal, who shall work diligently to gain more subscribers for The Brethren Journal." I am not sure that any of our churches still elect a zealous agent for The Brethren Journal . Unfortunately, the absence of these advocates may be contributing to the hardship facing The Brethren Journal today. Although there are still approximately 1800 members in the Unity today, the current circulation of The Brethren Journal is only 864. Some congregations have made the decision to increase the circulation of The Brethren Journal in their individual congregations by paying for a subscription for all members. This begs the question, "Should each Brethren household receive a Brethren Journal?" "Should the local congregations make sure its members receive a Brethren Journal?" "Is the expense of a subscription for each member worth considering as a line item in local church budgets?"

Financial problems aside, *The Brethren Journal* continues to be a source of information on current events within the Unity. It also has a proven track record as a dependable source of historical information and vital statistics accessed by many people within and outside the

Fall Synodical Committee Meeting October 5, 2013 – MINUTES

(Note: All attachments mentioned in the minutes are posted on the Unity website. If you require a copy of the attachment, please contact Liz Ripple.)

President James Marek opened the meeting and welcomed everyone to the meeting. There were 48 people present: Synodical Lay members (14) – J. Marek, L. Ripple, D. Merz, D. Weise, R. Dusek, R. Runnels, M. Chlapek, H. Treybig, R. Schlechte, R. Brinkley, A. Kocurek, G. Farrow, D. Kocian, L. Parthum.

Ministers (13) – L. Butcher, J. Emerson, M. Groseclose, J. Heckman, J. Hejl, L. Junek, L. Koslovsky, M. Labaj, V. Mitchell, B. Rinderknecht, N. Strickland, T. Tallas, J. Terrill.

Others -21. (Roll Call is on the Unity website)

The Morning Devotional was brought by Rev. Vanessa Mitchell. She read from Jeremiah 1:1-4 and 5-10. Rev. Mitchell said that we need the fire of the Lord in the Unity as a group and we need to have a constant

appetite for Jesus. We worship God in everything we do – through prayer, even the business of this meeting today is a way to worship God. Rev. Mitchell also gave the opening prayer.

James read the Unity Prayer: "Holy Spirit, as in the past you united different men and women and made them one, so bring us together in a oneness that celebrates our diversity of talent and ability. May our personalities blend in a superb harmony, as, laving our egos aside, we learn to prefer one another and to delight in encouraging the gifts we see in others. Let there be no star temperament, no prima donna behavior among us, but a sense of ensemble, as we try to be as anonymous as possible so that you can shine through our efforts to the glory of Christ. And when all is done, may we be in the wings and HE in the spotlight, taking center stage and receiving all the applause! Holy Spirit, you who are fully God and yet so anonymous, hide us that we may reveal Him. Amen."

of the referendum items passed. There were no questions (see attachment – Agenda #III). There was a motion made by D. Weise to accept the results as presented; second by Bro. Groseclose. Motion passed.

A motion was made by Bro. Jim Heckman to accept the minutes from the 2013 Convention and from the April 13, 2013, meeting; second by Dan Merz. Motion passed. (Secretary's note: On page 19 of the convention minutes, Suzie Dusek is noted as having seconded the motion regarding the salary for the State Youth Coordinator. Suzie Dusek was not a member of the convention, Beth Dusek seconded that motion. This will be noted as an addendum to the convention minutes.)

The list of candidates for Unity Offices were: Unity Archivist - Clint Machann; Brethren Bookstore Manager - Diane Heckman; Brethren Journal Treasurer - Dorothy Milberger; Hus School Board of Trustees Chairman - Mark Olsen; Hus School Board of Trustees Treasurer - Ron Krueger; Hus Board of Trustees Synodical Representative - Phil Michalik; Board of Christian Education - Jean Kotrla and Dorothy Kocian; Foreign Mis-

sion Board - Joyce Baletka, John Brinkley, Anne Wentrcek; Home Mission Board - Dorothy Hinson, Ben Kruse, Angie Hairrell, Alton Urbanovsky, Martha Dove, Claren Kotrla. There was discussion. A motion was made by Bro. Tommy Tallas to accept the slate of appointments as presented and to grant authority to the Executive Committee to fill the Hus Board position if Phil Michalik does not accept; second by Bro. Heckman. Motion passes.

Rev. Jimmy Hejl led the installation ceremony of the new Executive Officers: President - James Marek, 1st Vice President - Rev. Lawrence Junek, 2nd Vice President - Rev. Mike Groseclose, 3rd Vice President - Rev. Jerry Terrill, Secretary - Liz Ripple, Treasurer - Dewyan Weise, Financial Secretary - Dan Merz. James thanked Rev. Jimmy Hejl, Rev. Tommy Tallas, and Marvin Chlapek for serving on the Executive committee from 2011-2013 and also for their past service.

The committee discussed renewing the 1-year ministerial license for Rev. David Johnson and Rev. Larry Butcher. Rev. Butcher plans to retire next year in September. There was discussion. A motion was made by

Rev. Junek to renew their licenses; second by Rev. Heckman. Motion passed.

President Marek reported that the Unity has had to advance The Brethren Journal \$1500.00, and they have paid back all but \$444.25. They will still need \$7,000.00 to finish the year. Alice Kocurek - Brethren Journal treasurer, came forward to give her report (see attachment - Agenda VII). She stated that the Journal does have a future. Cathleen Schlechte (BJ Editor) also came forward and reported that the BJ committee has had a meeting and some of the things they want to do include try to focus more on advertising; increase the subscription rate to \$15 a year, and the special rate to churches will be discontinued; increase the rates on religious ads; work on having a facebook page; finding a new printer, the set-up person wants to quit - hopefully they can find someone who could do both of these jobs. Bro. Mike Groseclose, President of the BJ Business Committee, reported the need for the Journal to be more financially responsible – to charge what needs to be charged. There was discussion. 864 journals were printed last month. There was a question asked about email subscriptions and discussion on hard copies vs. on-line versions.

A motion was made by Rev. Junek to loan *The Brethren Journal* \$7,000 so they can pay their bills until the end of the year; second by Harvey Treybig. Discussion. The loan would come from the contingency fund. The motion passed. There was discussion on how the loan would be paid. A motion was made by D. Weise to allow the executive committee to work out the payment plan with the loan; second by Rev. Groseclose. The motion passed.

A motion was made by Rev. Mitchell to put the BJ on the website for everyone for free; second by Rev. Rinderknecht. There was discussion. An amendment to the motion was made by Gayle Farrow to add the words "have the business committee address". Amended motion: Have the business committee address putting the BJ on the website for everyone for free. Second by Robin Brinkley. Amendment to the motion passed. There was discussion on the amended motion to have the business committee address putting the BJ on the website for

everyone for free. Discussion that the business committee would review the proposal of putting the BJ online for free and consider the financial impact, etc. It would not be put online for free until this financial impact is figured out. James said we need to see how severely cutting the number of printed copies would affect the printing costs. If our costs are not cut commensurately by only printing a few paper copies, it would not be wise to do this. Amended motion passes.

A motion was made by Gayle Farrow to accept the proposal from *The Brethren Journal* to raise subscription and advertising rates (\$15.00 per issue of the BJ); second by D. Weise. Motion passes.

President Marek had Kent Laza, Chairman of the Foreign Mission Board, come forward and give his report (see attachment - Agenda VIII; this also includes a "Mission Funds Income Report" from M. Chlapek). A 40% decrease to each program is proposed. There are no reserves available; funds would come from the contingency fund to meet the budget for 2013. Discussion. Ben Kruse had "mission coin banks" that he suggests to give to church members or

anyone that wants to contribute for missions. More discussion. There was no report from the Home Missions Board. Rev. David Johnson serves as the Chairman. A motion was made by Rev. Larry Koslovsky to continue with the current missions 2013 budget that we presently have (\$67,000 for both home and foreign mission budgets) until next September 2014; second by Rev. Rinderknecht. There was discussion. Bro. Mike Groseclose announced that there will be a Unity Golf tournament to raise money for missions. More discussion. A paper ballot was taken on the vote. While the votes were being counted, Bro. Mark Labaj gave a report on the college campus ministry (see attachment - Agenda A). The motion passed 23-3. Kent reported that both boards, Foreign and Home Missions, have a Power Point presentation that they can present to the churches.

An invitation has been extended by the Nelsonville and Wesley Brethren Churches to host the 2015 Unity Convention. That year is the 600th anniversary of Jan Hus's martyrdom and plans will be made to recognize that occasion. The date will be decided later and may be held on Friday, Saturday, and Sunday. Speakers for the convention will be contacted soon. A motion was made by Rev. Tallas to accept the invitation from Nelsonville and Wesley; second by Dorothy Kocian. Motion passes.

We have received a gift deed for 2 lots that are located in Cade Lake. Dan Merz (Nelsonville) and Ted Hejl (Taylor) - (both men are attorneys) - have looked over the paperwork. There was discussion. A motion was made by Rev. Junek to pursue accepting the gift deed; second by Harvey Treybig. Motion passed.

President Marek reported that Bro. Jimmy Hejl is willing to make the trip to the Moravian Synod Southern Province meeting, which will be held April 3-6, 2014, in Black Mountain, North Carolina. A motion was made by Rev. Groseclose to send Bro. Jimmy Hejl as the Unity representative and pay the air fare/travel expense for the trip; second by Rev Tallas; passed.

President Marek reported that back in 2003 or so we had a seat on the Board of World Missions. There were some issues that came up, and in July 2003 we withdrew from the board. We currently have sent representatives to the meetings, but they do not vote.

The BWM are modifying their bylaws and we are a part of those bylaws. We need to let them know if we want to formalize this arrangement. There was discussion. A motion was made by Rev. J. Hejl that the Unity of the Brethren accepts a seat on the Moravian Board of World Missions and will become active again; second by Rev. Groseclose. After more discussion, the motion passed 24-2.

A motion was made by Rev. Junek that the Chairman of the Foreign Mission Board be the Unity's representative on the BWM; second by Dan Merz; discussion; motion passed.

President Marek reported about the creation of a Communications Committee. He said that we could offer names to serve on this committee and by the next meeting have a slate of people to elect. We need some younger people – the 30-somethings - to serve on this committee and we need to focus on ideas for this committee – particularly the website. The Brethren Journal business committee will investigate the possibility of putting the BJ online for free. A motion was made by Gayle Farrow to have the executive committee appoint

Being my mother's son, I excused myself from the table and intercepted her at the door.

"Excuse me, ma'am," I offered, "but would you like me to walk you to your car?"

Her response was not at all what I expected.

She stopped abruptly, looked me in square in the eye and asked rather emphatically, "Why?!"

To be honest, I could not even be sure it was even a question because of the tone in which she delivered it.

Having dealt with those of the

feminine persuasion before, I quickly realized that I was on very dangerous ground and that my footing was tenuous at best. The warning lights and sirens in my imagination were not helping matters either.

Trying to sound even more Texan than usual I truthfully offered, "I meant no offense ma'am. That's just the way Mom raised me."

At that, she relaxed and said, "It's always good to meet a young man (her words, not mine) who does what 'Mom' says." With that she smiled and offered me her arm.

When we arrived at her vehicle, formal introductions were made and the conversation turned to our respective family trees. To my delight, we then discussed history in general.

Eventually, the evening chill finally overcame whatever warmth the coffee and conversation had provided. We said our farewells and she drove away.

I will never forget that snapshot in time and the wonderful conversation I had with this kindred spirit. It was one of those special, unplanned moments that I thanked God for arranging. That sense of gratitude was made even more special because within a year this wonderful woman passed away.

It also makes me grateful to Him for the wonderful mother He gave me and for the lessons she taught me, although I confess she may have left this world wondering just how many of them managed to sink in.

Industry Brethren Church Dedication of Cemetery Historical Marker and Columbarium

On Sunday, October 20, 2013, the Industry Brethren Church in Industry, Texas, dedicated its Texas Historical Cemetery Marker and Columbarium. Sheila Coufal, President of the Board of Elders, recognized some of the honored guests, including Rhetta Chandler of the Czech Heritage Museum; Roxanne Johnson, Fayette County Historical Commission Chairperson; Industry Mayor, Alan Kuehn; County Commissioner, Bobby Rinn; Unity of the Brethren President, James Marek; Unity of the Brethren Secretary, Liz Ripple; Grace Holcomb of the Austin County Historical Commission; and Unity of the Brethren Rev. Jimmy Heil. **Austin County Commissioner Bobby** Rinn read a Proclamation signed by County Judge Carolyn Bilski and presented it to the church.

The service with the sermon delivered by Rev. Kay Polasek was held at 2 p.m. Following singing "When We All Get to Heaven" and "In the Garden", the Shelby American Legion flag bearers carried the U.S. flag out of the church as attendees followed them to the cemetery area. Rev. Kay Polasek led the responsive reading of the dedication, and Sanford Schmid unveiled the marker.

The cemetery was established in 1880 with the first graves being L. & Rosalie Marek. The earliest military burials are of Ernst Maeckel (served in the Civil War), Bennie Dockal, and John Ripple, Jr. Red, white, and blue balloons were released by family members or friends of the 21 veterans buried in this cemetery (the veteran's name was attached to the balloon), plus balloons were released for the veterans that were members and held their memorial services at the church. November 2013

Dear Partners in the work,

Happy fall! We have been busy in September and October with a short-term team and visitors, traveling, retreats, and 3 birthdays. With all of this we have felt busy and a little off track. May and the local church have also had their own troubles.

Joan, from the local church, the one who loves to go out and share with her family and who was hosting the church, is now full of fear, anger, and bitterness. She gets angry at her relatives that turn from the Lord, and holds it against them. Also during the last months she has received persecution for hosting the church and believing in Jesus. Since then she has not hosted the church nor attended the group in the new location. She won't even speak to May, even though May has asked for forgiveness and Joan said she forgave her, obviously she has not.

Lord we pray for Joan. We ask you would convict her of her sin, her anger, her self-righteousness. Lord, break the fear of people and free her from this grip that is leading her down the wrong road!

May has also had a few bumps in the road. If you remember, last year, when we were in the States, May went on a gambling spree and got herself into a heap of debt and sin. She is still in that hole. This week we have found out even more of what she did. Even though she loves the Lord, she struggles with lying, gam-

bling, money, and distrust of others. Her husband found out a little about what she did and beat her 2 weeks ago, which may have given her a cracked rib. Talking and praying with her, it seems she has always been abandoned by her parents and step parents all her life, and it still goes on today, leading to mistrust, and feeling unloved deep in her heart. Michael and our teammate met with her husband last night to tell him ALL May had told us she has done. He only knew a part of it. Today she said lots of freedom and hope has come back to her heart as her husband didn't throw her out and hasn't been violent. Isn't that the gospel. Jesus knows ALL our sins, and yet He still loves us, we need not fear.

Lord, we pray for May to be truly transformed and set free by your love. Help her to speak the truth, to get out of debt, to trust others, to trust your love, to be reconciled with her husband. To know deep in her heart of your love and forgiveness.

Because of various things, the local group has not met together for 2 weeks now. We are happy to say they have finished studying our 11 discipleship stories from the Bible. The last time they met the 3 women evaluated their group and asked themselves if they were a true church, or just a Bible study. They looked to see if they were: meeting together, sharing communion, giving money, loving God and others, doing and receiving baptism, making disciples, praying, helping and serving others. Their answer was "Yes, they wanted to be

a church of Jesus and they were doing most of these things." The only things they had not done yet were baptize people and make disciples that would grow up in Christ to go and make more disciples. So when they meet again, we hope they can pray about and be challenged to start new groups, to truly make disciples that will go make disciples. The method and stories are SO easy, they are not the problem, people's hearts are. We all come up with excuses why it is not culturally appropriate to share, or how we don't know how to share the gospel.

Lord, we pray that this group would meet again, and You would pour out Your Spirit on them. Help them to be willing to go and start new groups. Help all of us, whether abroad or at home, to obey You by making disciples.

We will head out for another visa run to Thailand in November. Then we hope to get another 3/6 months visa to last us until the beginning of April when we will have to leave because of baby #5. Yes, we are going to have another baby in Thailand. When will those Woos stop? Well, you can be sure we will stop after this one. I, Caroline, am making Michael take the proper precautions. We are happy and a little surprised. Due date is May 8. There are two possible visas opening up to us that we hope we can get in June that will provide vear-long visas.

Lord, thank you for these visa opportunities and thank you for a healthy Woo #5.
