



INSTRUCTIONS FOR ANSWERING THE 2023 QUESTIONNAIRE FOR THE UNITY OF THE BRETHREN

General Instructions: This report is for 2023 (ending December 31, 2023). The Secretary of the congregation should complete the questionnaire. Some questions will require help from the Sunday School or other organization officers. This questionnaire will be most useful if the Board of Elders reviews it before it is sent to the Unity Executive Assistant. You can complete the fillable form and email back to Loree or do the paper version and return it in the enclosed envelope.

The questionnaire should be completed by APRIL 17, 2024.

“Active” and “Inactive” membership totals are determined by the local congregation. Active membership is the basis for determining Brethren Fund payments which are currently \$40 per member.

Question 3: Inactive members are defined by each congregation. These are **not included** in active members.

Question 4 & 5: Number of children that have been baptized but are non-confirmed and the number of people that attend worship services regularly, but are not members of your congregation.

III. **Christian Education** – This section should be completed by someone familiar with the educational program of the congregation, perhaps the Superintendent or secretary of the Sunday School or Christian Education Committee.
