



President's Column . . . James Marek Played for a Fool or Blessed?

After a particularly stressful day at work, a couple of my coworkers and I

decided to go out for dinner. As we finished eating and were exiting the restaurant, a welldressed, middle-aged man approached us. He said he had been standing outside the restaurant trying to work up the courage to ask someone for



As I listened to him, I could not help but remember a very similar situ-



relief. He said that they had driven from San Antonio to bring his wife's dad back to Fort Bragg. As they were leaving, he accidently left his wallet and cell phone on the top of his car and they were both lost. He asked if we could help him by giving him money for gas so that he could drive back to San Antonio. He, too, promised that if we helped him he would personally drive the money back to us in Taylor when he got back to San Antonio.

In both cases I decided to help each of the stranded travelers, but I

did not feel very good about it in either case. Although I decided to help these 2 men, I had not given to them cheerfully. I felt anxiety at the possibility I had been duped and these 2 men were nothing more than con men. I struggled with my decisions and even felt remorse as I became more convinced I had been tricked. Then I felt guilt for being almost angry at these 2 men for talking me out of my money. That night at the restaurant, one of my coworkers, who had witnessed the episode with the man, assured me that, although I would likely never see the money again, it was the right thing to do to help him. My co-worker even insisted that I accept money from her to help minimize what would most certainly be my financial loss.

The next morning as I was reading the Upper Room, the topic of the devotional was (yes, you guessed it) giving to those in need. The closing part of that day's devotional included these words: "The gift we had received was a reminder that we are not called to judge human hearts. We are simply called to emulate Jesus by responding with compassion to the human needs we encounter." The timing of this devotional seemed to be anything but coincidental. I felt God had responded to the angst I had felt with each person I had encountered. As I thought more about this, it

seemed clear to me that while my heart was not in the act of giving with either of the men, it was the right thing to do. If these 2 men were truly in need and I had the opportunity to help them, that was a blessing. If they were both con men (and it appears they were) it may be that they had provided a blessing for me. Here's what I mean. By responding to their plea for help because my faith demands it, and if I lost something of value in the process of extending compassion, I believe scripture suggests that acts such as these may result in the storing of treasures in heaven that will last for all eternity because of the small financial loss I may have suffered.

The decision to give when asked is always a tough one, and I, like most people, have failed to respond on numerous occasions for fear of being taken for a fool. These 2 situations, however, have helped assure me that giving to those in need is a chance to demonstrate the love we know in Christ to those less fortunate while quite possibly providing opportunities for us to lay up treasures in heaven that will be ours forever. I am grateful for my coworker who supported and encouraged me, and I am also thankful for the way (I believe) God spoke to me through the Upper Room just when I needed His correction the most.



President James Marek called the meeting to order. Everyone joined together in the singing of "To God Be the Glory" accompanied by Liz Ripple on the piano.

There were 56 people in attendance (see attached Roll Call).

1. Opening Devotional – Rev. Nello Strickland - "Wake Me." He read from Ecc. 3:6-7. Bro. Nello encouraged everyone to keep going with their spiritual journey. He ended the devotional by singing "In His Time."

2. Bro. Larry Zabcik led everyone in the Unity prayer.

3. A motion was approved to have the convention on July 10-12. The convention will be held at Nelsonville on Friday & Saturday and at Wesley

on Sunday. Registration will begin at 9 a.m. on Friday. The Executive Committee recommended to set the delegate fee at \$250 which was approved.

4. Convention planning - This convention will be about praise, worship and celebration. 

college education. The best action seems to be for us to go through this process and get the formal requests from Rosenberg and from Ben and to consider Ben for a license in the fall. Discussion. From a by-laws standpoint, things have not been fulfilled. A motion was approved to extend Ben's ministerial student status for 1 year (following Article III, E, 9-B: Under unusual circumstances, this track of study may be extended if satisfactory progress is being made. Failure to complete the study within 5 years without an extension of the Synodical Committee revokes the ministerial student status). James thanked Ben Kruse for his service and reassured him that we are pleased with his progress and give him an extreme vote of confidence.

8. Dorothy Kocian has served as the West representative for 43 years and is stepping down. Darrell Kolinek (Austin) also wants to step down. A motion was approved to have Roy Janek serve as the West rep. and Eric Haynes as the Austin rep.

9. Rev Tommy Tallas gave a report on the Minister's Retirement Program. The committee members are Leonard Mikeska, Dan Merz, Tami

Laza and Adelle Moorehead, and Bro. Mike is the Synodical liaison. This program was created many years ago, and due to all the government regulations, pastors that have come into the Unity after 1999 are not eligible to participate. A need to modify the current Minister's Benefits Program has been identified and an effort is underway to restructure the program so that all Unity pastors are eligible to participate. Bro. Tommy has consulted with an investment advisor, Jessica Forrest with Alpha Capital Management (an independent professional investment advisory firm in Austin), and is exploring the options. The current program is designed for fulltime pastors according to the bylaws, and has also been limited in the past only to ordained pastors, even though this is not in the by-laws. These items can be reviewed. The committee will be meeting before the convention. Comments are welcome.

10. Executive Assistant Position (*Potential Convention Committee in addition to a Motions and Finance) – This would be a potential position for someone who would serve as a non-voting member on the executive committee. This person would

stay on as executive boards change and the responsibility would include making sure that unfinished projects assigned by the Synodical Committee or convention would be completed. We would need to create a job description for a part-time paid position in the \$15,000 range. Dewyan explained further what this position could be. This topic is for further discussion and will be discussed at Convention.

11. Report on the Minister's Retreat – Report given by Dr. Larry Koslovsky. Two retreats were held, one in Oct 2014 and another in March 2015 at Camp Allen in Navasota. Each time 8-10 pastors were able to attend. The pastors got together to worship, study, and encourage each other. Bro. Larry thanked the executive committee for the financial support which authorized \$2,500 in October and \$2,000 for March. He hopes they can continue to do this 2 times a year.


12. Missions update (*Potential Convention Committee in addition to a Motions and Finance) – James reported that in 2014 we collected over \$146,000 for missions. Each mission (foreign & home) had a budget of \$67,000. We are still about 15% short in Home Missions (Agenda 19a, President's report).

James reported that the excess in the Foreign Mission account will stay there because that is where they were designated to go. He expressed that these budgets are not competing against each other. We have tried to keep the figures current and relayed the information to the churches.

The amount to be transferred to the home missions will be \$21,290.31 to fulfill the budget agreement from October 2013. James explained how this figure was derived.

Bro. Jim Heckman gave an update on Cade Lake and asked everyone to keep them in your prayers. The biggest need he has is for someone to work with the youth every week. He is also looking at expanding the sanctuary or building a new one and turning the existing one into classrooms.

Kent Laza (Foreign Missions Board Chair) reported on the Thiessen's. The Thiessen's are now in Canada and have asked for help to get a computer and some software so Anne can continue her work as a teacher and send lessons to Mexico. A motion was approved (not to exceed) \$750 for

the items and \$60 a month for a good cell phone plan.

The Woo's are back in North Carolina and will not be working as missionaries for a while. They are concerned about their salaries. Phil & Eunice Raiford would like to attend the convention. Churches are asked to contact Kent if they would like a visit from them. Kent reported on the spring meeting of the Board of World Missions in Salem, NC. He was impressed by their work and hope we can join them financially. A motion was approved to continue to support the budgeted amount for the Woo's and Thiessen's for 2015.

13. Potential By-Law Changes (*Potential Convention Committee in addition to a Motions and Finance) - Liz reported on some recommended by-law changes (see Agenda 13). James said another potential change to the by-laws would be to have the responsibility of website updates and changes to come through the secretary.



Still, We Are Here

Over the course of the last four issues I have shared with you a rather detailed account of the first century of our history following the death of Jan Hus. Through them I have tried to share with you both my fondness of history and, more importantly, my particular fascination with our history. This is much more than a history that we share. It is a continuing story in which we are simply the latest chapter.

I will admit that the articles were somewhat lengthy, but I felt it was important to relate that first century in as detailed a manner as possible. If nothing else, I have convinced more than a few people in Taylor that I can be almost as longwinded on paper as I am in person.

In fairness, you must admit that God has blessed us with a remarkable heritage. As proof I only have to point out that in July we will remember the life of Jan Hus, who was martyred July 6, 1415. Although we celebrate the life of Jan Hus every year, this year has the added significance of marking the 600th anniversary of his martyrdom.

Reflect upon this for a moment. Six centuries have come and gone in the affairs of men. Many generations have come and gone. As I studied page after page of our history, one thought kept resurfacing in my mind. There were so many times the church that we know and love today could have failed to materialize. Still, we are here.

So many events have occurred that could have forever closed the door upon us. Yet at each critical juncture, God was there for us and either held the door open or opened a new door. Ours has not been an easy journey, but then, the things in life we


Youth Fishing Retreat at Port O'Connor

consider worthwhile rarely are.

Hus said, "Truth conquers all." Hus tirelessly pursued the truth. He rigorously studied what he believed to be true. He constantly taught what he believed to be true. He preached with zeal what he believed to be true. He resolutely stood on what he believed to be true. He was also mercilessly persecuted for his pursuit of the truth.

Hus was promised safe passage to Constance, a fair hearing and a safe return. Of these, only the first promise was kept. He was imprisoned next to a sewer prior to his hearing and became ill almost to the point of death as a result. Time and again Hus was asked to recant his teachings. He would not. Hus challenged his accusers to show him in scripture where he was in error. No attempt to do so was ever made.

As part of a foregone conclusion, Hus was found guilty. He was forced to endure a ceremony of degradation. In that ceremony he was stripped of his vestments and a pronouncement was made by the council that the name of Jan Hus be forgotten by history. As Hus was led to his execution, his books were publicly burned. Hus, like his books, was burned at the stake. History reminds us that he faced death singing. Six centuries have passed and we still celebrate the life of the man the council wanted forgotten. Still, we are here.

After his death Hus was viewed in many different ways. Some saw Hus as Catholic. Others viewed him as Protestant. Some saw him as a patriot. Others viewed him as a champion of church reform. Some saw him as a great moral teacher. Others viewed him as an enemy of the Papacy. There was no unified vision of who Hus was or what he actually stood for. Still, we are here.

The movement that gained momentum under Hus then fractured into a varied collection of sects and parties each with its own vision. Corruption ran rampant through both the established church and the state. The chaos of war was thrown into the mix. Still, we are here.

Chelcicky wrote of the need to renounce the world and return to the original church and the teachings of Jesus and the disciples. He was a man of peace and integrity who considered the war an abomination to both sides. He took exception to the compromise reached between the Catholics and the Utraquists. Although a spiritual leader, he would not unify his followers into a church. Still, we are here.

Gregory led a band of followers to Kunwald. Viewing the established church as lacking in discipline, they chose to forever break with Rome. Persecution was their reality. They established a new priesthood, or Unity, and the severity of their persecution increased. Still, we are here.

Upon Gregory's death, the Unity became divided. Division arose as to how it should respond to secular authority. The sense of division grew as it struggled in its understanding of salvation. Two distinct camps formed within the Unity. Eventually a schism took place that forever divided the Unity. Still, we are here.

All of these things occurred within our first century. There was still much more to come. In the centuries that \Rightarrow followed events seemingly conspired time and again to forever halt what began with Jan Hus.

The Unity was misunderstood. It was persecuted. It was asked to take sides in a civil war. Its leaders were imprisoned. Its members were tortured and executed. It was given an ultimatum to convert or leave. If its followers were to leave, then where were they to go? Who would take them in? Even when such places were found, their new hosts often insisted that they abandon their ways and adopt those of the land. This is only a partial list of the many trials faced. Still, we are here.

One is forced to consider the fact that any one of these events could have put an end to us. The fact that we have survived them all is both amazing and a clear indication that God's hand has been on us all along. In a much earlier article I shared with you a passage of scripture from Revelation concerning the church in Philadelphia. Throughout my study of our history I was continually reminded how well it applies to us. As such, it bears repeating.

Revelation 3:8 (NET) – "I know your deeds. (Look! I have put in front of you an open door that no one can shut.) I know you have little strength, but you have obeyed My word and have not denied My name."

One of the books I read was J. E. Hutton's *A History of the Moravian Church*. Hutton's ability to present history in the form of a narrative really brought our story to life. As I read each page in his book I came closer to one inescapable conclusion. We are still here, and therefore we exist for His purpose rather than our own. Before closing, I feel obligated to share Hutton's final paragraph from that book. These words were written a century ago, but in them I found a wonderful affirmation that validated my conclusion.

"As the Moravians, therefore, review the wonderful past, they see the guiding hand of God at every stage of the story. They believe that their Church was born of God in Bohemia, that God restored her to the light of day when only the stars were shining, that God has opened the door in the past to many a field of labour, and that God has preserved her to the present day for some great purpose of His own. Among her ranks are men of many races and many shades of opinion; and yet, from Tibet to San Francisco, they are still one united body. As long as Christendom is still divided, they stand for the great essentials as the bond of union. As long as lepers in Palestine cry "unclean" they
