The Uncle I Never Knew

He was but one of the many young men who answered his country's call in World War II. He was also one of the many who paid the ultimate price. He left behind a wife and a very young daughter. His name was Willie Mikeska, and he was the uncle I never knew.

Uncle Willie served aboard the heavy cruiser *USS Indianapolis*, which delivered the components for the atomic bomb dropped on Hiroshima that led to the war's end. Although a terrible weapon, it forced the surrender of Japan, saving an untold number of lives on both sides by preventing an invasion of the Japanese homeland.

I am unable to tell the story in his words, so I tell it using the exact words of the men who shared in the tragedy and survived. It is a difficult story, but it is a story that needs to be told and retold... lest we forget.

The USS Indianapolis was the flagship of the Fifth Fleet. She was 623 feet long, 66 feet wide, and displaced 10,000 tons. She had an illustrious history even before the war. President Franklin Roosevelt used her as his ship of state traveling to various ports around the world. In this capacity, she was more than a ship, she was a symbol of American might and power.

Uncle Willie grew up on a Central Texas farm, and I suspect seeing her for the first time must have been quite an experience. In the words of one survivor: "Oh, it was the biggest thing I ever seen in my life. I looked

at it like that, and I said, 'Oh, my God. Old country boy out there, farm boy, I never seen a tractor that big."

The *Indianapolis* was commanded by Captain Charles Butler McVay III. McVay was a career naval officer and the son of an admiral. McVay had the respect of his men and his superiors. It was just a matter of time before he would achieve the rank of admiral. One survivor stated: "You enjoyed being on the Indianpolis." Another: "I could have never asked for a better ship and better men." The ship had an impressive service record, earning a total of 10 battle stars. She escorted 21 Matson liners loaded with Army and Marine personnel to Australia. From there she headed to Alaska and the Bering Sea. The men wore heavy winter gear while battling rough seas. One man stated: "We'd go over one wave and under two." Another: "The ship was awash almost all the time." Still another: "We had to go out break the ice off of the life lines."

History books tell us about the Japanese attack on Pearl Harbor. They often omit the fact that Japanese troops occupied several of Alaska's Aleutian Islands. Upon arrival, the *Indianapolis* sank a Japanese ammunition ship and then trained her 8-inch guns on enemy strongholds on islands such as Attu and Kiska.

She was then ordered to the South Pacific, where she was needed at the battle of Tarawa. According to one man: "I wasn't even 18 years old. They wasn't nothing but a bunch of kids." She saw action in the Marshall

Islands, Saipan, Tinian, Guam, the Philippine Sea, and Peleliu. The first week of February 1945, the Indianapolis was a mere 30 miles off the coast of the Japanese homeland in support of aircraft carriers whose planes were wreaking havoc in Japan.

From there the Indianapolis was ordered to the Island of Iwo Jima to take part in the shelling of the island prior to and during the amphibious assault. A number of her crew witnessed the historic raising of the American flag on Mount Suribachi. Before ground forces had taken complete control of Iwo Jima, the Indianapolis was ordered to proceed to the island of Okinawa, where a brandnew threat awaited her.

By the time of the battle of Okinawa the Japanese struggle became a desperate one. With few experienced pilots remaining, Japan turned to a new and frightening form of combat – the Kamikaze. These were suicide pilots whose mission was to fly their explosive laden planes directly into their targets.

The Indianapolis was credited with shooting down seven. As a heavy cruiser, she was a large target and her luck could not hold out forever. The

following account is a compilation of statements made by some of the survivors: "At Okinawa, there was an awful lot of Kamikaze planes. Some days there was a hundred up there. You know that was a really scary thing. - You can't dig a foxhole aboard a ship when you have Kamikaze planes coming at you. – And we happened to be at the tail end of the picket line that particular day. – It was early in the morning when the sun was just coming up. – We missed it. It come in right over the bow. – And a plane come out of the sun that... No one saw it. -They just said, 'Man your battle stations! Man your battle stations!' – I saw the plane, and he looked like he was coming right to me... - That thing hit the fan tail and we didn't have armor plating on the fan tails. – And the bomb that the plane carried went clear through the ship, all of the decks. - It went down. It didn't hit nothing solid till it hit the drive shaft and then it exploded, and it blew up underneath. - And that caught all these guys in their bunks."

In total, 9 men were killed aboard the *Indianapolis* with another 30 injured. Funeral services were held on

the quarter deck. The bodies were respectfully loaded aboard landing craft and taken to Okinawa for burial. The island was still far from secure and the American forces there were under sniper fire from a number of unknown locations. American forces took possession of the bodies for future burial.

The damage to the *Indianapolis* was extensive and she had taken on a good deal of water. Listing at 17 degrees, she made her way to Guam for spare parts before limping back to the United States for repairs. She continued to list for the duration of the trip. This made it difficult for the men to stand or to do any work.

She passed under the Golden Gate Bridge on her way to the dry docks of the Mare Island Naval Yard in San Francisco. The men were given leave while the 30-day repair work was performed. Many visited home, including my Uncle Willie, who had just enough time to visit his family before returning.

A number of men reported premonitions of an ill-fated journey. According to Mother's accounts, her brother Willie had such a premonition. One man stated: "The last day I was home, my mother was sitting on the front porch. She said, 'Oh, yeah, I know something's wrong. You don't act like yourself.' And I said, 'Well, I'm dreading going back this time. I feel bad about it.' And she said, 'Well, I wish I could go for you, but I can't. I wish I could go with you, but I can't.' And she said, 'But we know who can.' And I said, 'Yes, Mother. Jesus."

I can imagine similar conversations taking place between many sons and mothers throughout the United States, including perhaps my uncle and grandmother.

After 30 days, repairs to the ship were complete. She departed the next day under orders to proceed to Hunter's Point to pick up special cargo for delivery. Upon arrival, a huge crate

was brought aboard complete with a detachment of Marines to guard it. This crate held the components of the atomic bomb. A lead container was brought aboard and taken to the admiral's quarters, where it was welded to the deck. The captain was given the order that should anything happen to the ship, this container was to be put aboard a life raft before anything else.

All of this was Top Secret. The sailors began to speculate as to what was in the large container and some wagering took place. One thought it contained a Cadillac for General MacArthur. Another speculated it contained whiskey for everyone to celebrate the end of the war. The most imaginative was that the crate contained 20,000 rolls of scented toilet paper for the good general.

The *Indianapolis* was ordered to travel at best speed without an escort to Pearl Harbor. Averaging a speed of over 29 knots, she arrived at Pearl Harbor in 72 hours for refueling; a record for that size ship that still stands today.

From there she was to proceed to Tinian, where the cargo would be offloaded. As the mission was top secret, the *Indianapolis* would still not be provided with a destroyer escort. She arrived at Tinian without incident and offloaded her top-secret cargo. According to one man: "There was more brass on the dock that day than I ever seen before."

She set course for Guam to resupply, and there McVay received orders to proceed to Leyte Gulf in the Philippines. With the mission successfully completed, McVay requested a de-

stroyer escort. This was denied even though the journey was to cover some 1,500 miles. According to one survivor: "They told him no. Says, 'You don't need one There are no enemy submarines in the area where you're going.' So, we proceeded without one."

The premonitions felt by the men were about to become reality. Visibility became poor so McVay issued the order to discontinue zig-zagging until conditions changed. Just after midnight on Monday, July 30, 1945, the *Indianapolis* crossed paths with the I-58 commanded by Captain Hashimoto. It was one of the few remaining operational submarines in the Imperial Japanese Navy. Hashimoto felt no need to use his manned suicide torpedoes known as Kaitens. He fired a spread of six torpedoes at two second intervals and waited.

At ten minutes after midnight one of the torpedoes struck the bow and the resulting explosion sheared it off. Two seconds later the second torpedo struck amidships. The resulting explosion ignited the aviation gasoline and knocked out the ship's electrical power. As a result, the engine room did not receive the order to stop the engines. Travelling at full speed with no bow, the *Indianapolis* was taking on water at an incredible rate.

Captain McVay quickly assessed the situation and gave the order to abandon ship, but with no electrical power the word had to be passed from man to man. "Captain said, 'Pass the word to abandon ship.' Well, all we could do is yell and scream, 'Abandon ship! Abandon ship!'" Some men



sensing the ship was doomed did not wait for the order. "I says, 'Go get us some life jackets,' so he went and he came back in a few minutes, and had one. So, he gave me that one. I didn't ever see him again." The ship began its death roll and nosed down into the water. An explosion threw Captain McVay clear of the *Indianapolis*. Ten minutes after the first torpedo struck, the aft section of the cruiser slipped beneath the waves.

"I was scared to death. I just remembered my mother saying, 'We know who can go with you,' so it prompted me to pray a little short prayer. Said, 'Lord, help me,' and when I did, I had a feeling of calm and wellbeing."

There were 1,916 aboard the *India-napolis* when she left Guam. An estimated 880 men managed to get off the ship, but their ordeal had just begun. Scattered across an area covering 20 square miles, the more fortunate found themselves in one of the six or seven

groups. "What do we do sir? What do we do sir?' Well, you know, being an officer, I didn't know what to do, really, I'd never been through this before." The remainder found themselves all alone in the largest ocean in the world.

The badly wounded clung to life for a few hours. Many men were covered with unheated oil that now had the consistency of tar. With daylight, some of the men found scattered life rafts and cargo nets. Those in groups spoke of distress signals and a rescue that was surely just hours away. As the hours passed, thoughts turned to their expected arrival. Surely when the ship failed to arrive a search would begin immediately. These hopes were doomed. Standard procedure was for arrivals to be noted. Non-arrivals were not.

Planes in the distance were seen from time to time. The men yelled and thrashed the water. This merely sapped them of their strength. They were too

Under a blazing South Pacific sun, the men suffered from sunburn and skin lesions. They prayed for the cool of night. Shortly after dark the men would feel cold and prayed for the sun to come up again. Dr. Haynes, the chief medical officer, wanted to help the wounded and dying but had nothing to give them. He was forced to take on the role of coroner for his group. If a man was thought to have died, Dr. Haynes would confirm this. He would collect the dog tags of the deceased and remove his life jacket so that another could have it.

Then the sharks came. A few at first, then more. They circled cautiously at first as if they were not sure what to make of it all. In time, they became more aggressive. Some of the men were bleeding. These men often found themselves abandoned by their comrades for fear of shark attack.

Then the sharks moved in. "First day, I think we lost maybe 20 the first day. The second day was carnage all over. – There were hundreds of 'em. Hundreds of sharks. – You had to stay in a group. If you was out there by yourself, the shark had you." Being in a small group was no guarantee of safety. A number of small groups also became prey.

"And Tuesday came and we knew they weren't coming. – The third day seemed to be the hardest and we lost the most men."

The ship's chaplain, Father Tho-

mas Conway, gave his all before giving out himself "And Father Conway, he'd run into these men, and they'd be burned and dying and he would try to comfort them and do what he could, and he exhausted himself completely. He became incoherent and he died from exhaustion."

According to one survivor: "I saw some great heroism, and I saw some great fright, and I saw some... things that I would never want to talk about."

Then, just as the last of their strength and will began ebbing away, a miracle happened on Thursday, August 2, at 10:25 a.m. A PV-1 Ventura piloted by Lt. Chuck Gwinn was headed directly toward one group of survivors. Some 150 miles from his base. Lt. Gwinn was flying at an altitude of 8,000 feet. Taking in about 20 square miles in his field of vision he spotted a man's head surrounded by a gray kapok life jacket. Gwinn referred to this as a miracle. A survivor referred to this as the providence of God. Refocusing his gaze, he spotted another, and another and another. In no time the scope of the situation became clear. Gwinn went into a dive to signal the men below that they had been seen. One man later said, "Most beautiful plane you ever saw in your life."

Gwinn sent a coded message to the base at Peleliu to send surface ships to the area immediately. A short time later a PBY Catalina piloted by Lt. Adrian Marks arrived on the scene to investigate. After assessing the situation, Marks radioed the base: "Make emergency flank speed. Minutes mean lives." His crew busied themselves

dropping supplies out of the back of the plane. They reported to Marks seeing men being attacked by sharks. Marks and his crew decided to ignore standing orders and attempt a water landing despite 8 to 12 foot swells.

Marks landed the plane, but it was clear from the damage incurred that it would never take off again. He radioed his exact location and then taxied his plane around as his men brought the survivors aboard. They focused their efforts on lone individuals assuming they made the easiest prey for the sharks. Once the body of the plane was filled, additional survivors were placed on the Catalina's wings.

Around midnight the first ship arrived. The *USS Cecil J Doyle* moved in and shined her light up into the clouds to illuminate a wider area and to give the men hope. The *Doyle* was joined by the *USS Bassett*, the *USS*

Ralph Talbot and the USS Ringness. The men were transferred from the plane to the Doyle. The PBY was then sunk and the Doyle headed for Peleliu.

The survivors in the water were now extremely weak. Men from the rescue vessels bravely jumped into shark infested waters to help them aboard. As they were brought aboard, the crews of these vessels took care of them. Captain McVay was eventually rescued, but he insisted his men be treated first.

Out of a crew of 1,196 men, an estimated 880 made it into the water on July 30. Of these, only 317 survived their ordeal at sea.

World War II ended just weeks later. Irate family members wanted answers. The Navy, rather than take the blame for not looking for the *Indianapolis* or denying her an escort, court-martialed Captain McVay.

Navy ever to be court martialed for losing his ship in a time of war. They even brought in Captain Hashimoto of the I-58 to testify. The survivors felt that this was an affront to the crew as well as to McVay. McVay was found guilty of failing to zig-zag even though Hashimoto testified he still would have sunk the *Indianapolis*. Many felt that although the proceedings were perfectly legal, justice had not been served.

Captain Charles Butler McVay III took his life in 1968.

Over 50 years after the tragedy, 12-year old Hunter Scott made this the subject of his school project for National History Day. He interviewed many survivors and even testified before the U. S. Congress. In October 2000, Congress passed a resolution stating that the late Captain McVay should be exonerated for the loss of the *USS Indianapolis*. This was signed into law by President Clinton. In July 2001, Secretary of the Navy Gordon R. England ordered McVay's official Navy record purged of all wrongdoing.

Additionally, a Veterans Memorial Committee suggested that the Navy award Father Thomas Conway the Navy Cross. This was denied in 2015.

According to Peggy Campo, the daughter of a survivor, "There were many, many men that worked so hard during the war, and the real heroes are the ones that didn't come home."

His name was Willie Mikeska, and he was the uncle I never knew.

Understanding the Story

Ask them how they got to church today. Did they arrive by car? Did they walk? Did they ride a bus? Allow children to respond and explain how they got to church. There are many different ways to get to church, but you all had to follow someone to get to church. Today we are going to learn about a man who had to follow God to get where God wanted him to be. But he wasn't going to church, but to a faraway place that he had never been to before. He had to trust that God knew what was best for him and follow God.

Tell the story of Abraham leaving his home and following God. You can read it from Genesis 12:1-7 or retell it in your own words. Emphasize that God had a plan for Abraham to be the father of a great nation – God promised Abraham that he'd have more descendants than all the stars in the sky.

Ask children if they can count the number of stars in the Milky Way? God's plans are always greater than we can ever imagine or dream. Just like God had great plans for Abraham, God has great plans for each of you.

As you give each student a Milky Way, tell them that God has great plans for (their name).

Milky Way Craft

Give each child a piece of black construction paper and star and planet stickers. Allow them to make a "Milky Way". Talk about how many stars and planets they have on their paper. Now rub all the empty spaces with a glue stick and allow them to sprinkle on glitter (messy, but worth it!). Now discuss the number of stars in the Milky Way and how God knows each of them!

From the Thiessen's in Mexico...

Rachel's Spiritual Warfare

March 28, 2017

Dear friends,

I (Anne) don't come from a background where spiritual warfare was mentioned much. At least not in those terms. I knew my brothers and sisters in Honduras did constant spiritual battle, but they used different words about the divisive attacks on young churches and the prayer and fasting and teaching that went into defending them.

Our recent visit with the pastor who is raising up a work in Rachel's town made me realize again how spiritual warfare can come in so many guises. The town is not far from the St. Peter town that we wrote about in the last letter.

After our last meeting with this same pastor, who visits Rachel's Mixtec town every week, he took our counsel to heart and immediately baptized Rachel and her husband Felix. It was perfect timing, because Rachel and Felix had decided to broach the subject on that visit. They were wanting to take this next step of commitment! Yay God!

And our pastor friend shared his vision with Rachel and Felix that they would be the new leaders of a new church in that town. They would no longer depend on outsiders to run their worship services for them. The

first test of this leadership came when the pastor suggested that the few believers in the town take turns hosting the meetings in their homes (there is no building). That's when the pastor figured out that there are divisions in the town (pretty normal for Mixtec communities) that keep certain families from visiting certain other families unless an outsider (like the Hispanic pastor) organizes the meeting, making it neutral ground. What to do? So-and-So won't come to So/So's house and vice versa. How do you build a church out of that?

This reminds me of Paul's exasperation with the Corinthians, "I hear from Chloe's family that you can't come to an agreement." Or his urging of his beloved Philippians: "I beg you, Euodia and I beg you, Syntyche, please find your common ground!" It makes me think that if Paul could get the querulous Corinthians to form a united church and get two strong women ministers in Philippi to agree on their love for Jesus, then we, too, have hope with communities that are traditionally divided.

But this means war. Because it is the Enemy that has pit us against one another, and he will do *anything* to keep us from restoring broken relationships. And he will do *anything* to keep the brokenness from coming under the light of Christ. We committed with the pastor and his wife to help him tackle this spiritual battle with fasting and prayer. I ask you to join us in our prayers for Rachel and Felix and their new church that God

Pastor Kay preaches on Sunday morning, has a young people Sunday School class, and has started a youth choir. Pastor Jim oversees the pastoral care of the congregation by visits and taking members to doctor appointments, etc. He also maintains the financial records by turning in receipts to Home Mission Board Chairperson each month.

As Pastor Kay is taking over duties at the chapel, she will no longer be a member of Home Mission Board. She is being replaced by Clarence Tillman Clark from Crosby Brethren.

At the Synodical Meeting in April, the Home Mission Board asked for a budget amendment of an extra \$10,000. Since the 2017 budget was cut by \$19,000, there was no allotment for salaries. This amendment would be for salaries of \$5,000 for Rev Heckman and \$5,000 for Rev Polasek. The amendment was approved, which makes the total 2017 budget \$58,000.

The Home Mission Board was granted a loan of \$10,000 for roof replacement and repairs. Projects are being planned to help repay the loan. If anyone would like to help with this project, please send a check through your congregation with a memo of Cade Lake Loan. This would be greatly appreciated.
