They say you cannot teach an old dog new tricks, but I beg to differ! I've seen too people experience many changed lives. I've seen too many people open their hearts to God and never look back. I've seen too many people make a difference in the world when others have sworn time and again that society is decaying, and things will never change. "Same old same old," they say. "It is what it is," they say. I know firsthand that God doesn't work that way. He brings to life that which is lifeless! He opens the most bitter of hearts! He turns ashes into beauty!

My 16-year-old Shih Tzu, Jack, has been near the door of death several times. He has a hard time hearing. He has hip dysplasia, poor vision,



several teeth gone, and more. However, if you saw little Jack trotting along on one of his cool morning walks, with almost a smile on his face, with his ears flapping away, you would never guess what he has been through. I've prayed over him in the waiting area of veterinarian offices, asking the Lord Jesus

This happy little canine has become a "comeback kid." I know that one day the Lord will call him to rest in peace, but for now, Jack inspires me to persevere with joy. For us, persevering with joy runs much deeper because we know the One who is our Maker.

God is calling you to remember who He is, to remember who you are in His eyes, and to believe that even though you may feel "very dried up," like your "hope is lost," or like you "are cut off completely" from Him, from His goodness, you are not!

Take a moment to call upon your imagination and visualize what a prophet from the Holy Bible, Ezekiel, experienced as he was commanded to share with God's people, who were utterly depressed. Their complaint to God as they felt so overwhelmed was:

"Our bones are dried up, and our hope is lost; we are cut off completely."

Take a moment and picture Ezekiel's role, God's power, and the "comeback" God outlines for them, to draw them out of their depression illustrated with a metaphor of a valley of very dry lifeless bones.

From the Holy Bible, the Book of Ezekiel, chapter 37:

"1 The hand of the Lord upon came me. and he brought me out by the spirit of the Lord and set me down in the middle of a valley; it was full of bones. 2 He led me all around them: there were very many lying in the valley, and they were very dry. 3 He said to me, 'Mortal, can these bones live?' I answered, 'O Lord God, you know.' 4 Then

he said to me, 'Prophesy to these bones, and say to them: O dry bones, hear the word of the Lord. 5 Thus says the Lord God to these bones: I will cause breath to enter you, and you shall live. 6 I will lay sinews on you, and will cause flesh to come upon you, and cover you with skin, and put breath in you, and you shall live; and you shall know that I am the Lord.' 7 So I prophesied as I had been commanded; and as I prophesied, suddenly there was a noise, a rattling, and the bones came together, bone to its bone. 8 I looked, and there were sinews on them, and flesh had come upon them, and skin had covered them; but there was no breath in them. 9 Then he said to me, 'Prophesy to the breath, prophesy, mortal, and say to the breath: Thus says the Lord God: Come from the four winds, O breath, and breathe upon these slain, that

they may live.' 10 I prophesied as he commanded me. and the breath came into them, and they lived, and stood on their feet, a vast multitude. 11 Then he said to me. 'Mortal, these bones are the whole house of Israel. They say, 'Our bones are dried up, and our hope is lost; we are cut off completely.' 12 Therefore prophesy, and say to them, Thus says the Lord God: I am going to open your graves, and bring you up from your graves, O my people; and I will bring you back to the land of Israel. 13 And you shall know that I am the Lord. when I open your graves, and bring you up from your graves, O my people. 14 I will put my spirit within you, and you shall live, and I will place you on your own soil; then you shall know that I, the Lord, have spoken and will act, says the Lord.""

Hus: Imprisoned and Tried By Jim Pokorny

Despite promises from the King and assurances from the Pope, Hus was now a prisoner. The enemies of Hus began to rejoice. But Chlum quickly rushed to the Pope, whose residence was in the palace, and reminded the Pontiff of his assurances. John XXIII simply shifted the blame to "his brethren" referring to the Cardinals.

At 9 PM, Hus was transferred to the cathedral where he would remain for a week under close guard. On December 6, 1414, he was moved to a Dominican monastery by the lake. Although the monastery offered a tremendous view, Hus was not encouraged by the sight. On these grounds stood a drafty tower next to an open sewer. Hus was imprisoned there, and his physical health began to rapidly deteriorate. Physicians warned the Pope that Hus was nearing the point of death. On January 8, 1415, Hus was transferred to a cell that offered improved sanitary conditions. Treated less harshly, he was allowed to read, write, and receive visitors. Here he remained for several weeks.

Meanwhile, the Council appointed a panel of three to investigate the charges brought against Hus. They began to badger him with questions and sworn witnesses. Although still physically weak, his request for an advocate was refused. As he was already deemed a heretic, Hus was denied protection of the law. At this, Hus declared that Christ would be his advocate.

During this same period, the friends of Hus were not idle. They continued to lobby for his freedom. John von Chlum badgered the Pope, wrote the King, and attempted to rouse the citizenry of Constance. King Sigismund eventually dispatched a letter to the Cardinals demanding the release of Hus. When the King arrived on Christmas Eve, he learned that the Cardinals had not yielded. Instead, they freed Si-

gismund from his promise on the grounds that Hus was a heretic and that the King had not consulted with them prior to his promise. This was shaky ground. Had the King left Constance, the Council would likely have broken up. They successfully pressured the King who formally withdrew his protest. He conceded that the Cardinals should be free to act in all matters concerning faith. Thus, the King effectively sacrificed Hus to the Council.

But Hus was no longer foremost on their minds. Their combined attentions turned to the schism. The matter of three popes took center stage. In a unified move, the Church officially brought charges against John XXIII. Heeding the proverbial writing on the wall, he fled Constance along with those loyal to him. At this point, King Sigismund squandered yet another opportunity to assist Hus and perhaps even rescue his own reputation. Instead, he bowed to additional pressure exerted by the Cardinals. Sigismund sanctioned the move to make the Bishop of Constance the official keeper of Hus.

During the night of Palm Sunday, March 22, Hus was taken in chains to Gottlieben, a towered castle nearly 200 feet tall. Upon arrival he was taken to the top of the Western tower still in his chains. In a small cell, his feet were chained to

"Thoughtful Service --A Payne Family Tradition" West, Texas 254/826-5321 a block. At night, his right arm was secured to the wall. Hus languished in these conditions for more than two months. His friends bribed his jailers in attempts to relieve his sufferings. Meeting with representatives of the Cardinals, they demanded that Hus be set free. They offered bail up to any amount and requested he receive a public trial. Ironically, such a trial was set for June 5. Hus was returned to Constance and a Franciscan Monastery instead.

A newly appointed commission began the trial of Hus at the time appointed. The moment Hus tried to speak in his defense he was shouted down. Liberties were taken with the writings of Hus. Hus tried in vain to explain that these were mere misrepresentations. He was shouted down even more. Once silent, his persecutors exclaimed that his silence only served to prove his guilt.

Two more hearings took place on June 7 and June 8. The King was present at both, and better order prevailed until the proceedings turned savagely upon Hus. Hus wrote to his friends in Bohemia: "They press upon me, threats and deceitful words, to induce me to recant." The explanations offered by Hus, although Biblical, were summarily dismissed. Accusations regarding his doctrinal teachings were blatantly false. His guilt was a foregone conclusion; the hearings were a formality. Hus now faced two options: recant or be burned alive.

Reports of Officers were enclosed in the Delegates Packets. Susan Skrabanek (New Tabor) made a motion to accept the reports as given. A second was given by Linda Flens (Taylor). **Motion Passed**

A Slate of Officers and a Slate of names for the Nominating Committee were presented at this time. A Motion was presented by the Chair of the Nominating Committee Ann Sebesta (Snook) to be brought to the Convention body during the Second Session of the Convention. **The Motion States:**

The Nominating Committee moves that for this convention only, elect positions 1, 2, & 3 for a 2-year term and positions 4 & 5 for a 4-year term. Subsequent elections would be in line with Article VII of the By-Laws. In order to have continuity for incoming members, Position 2 member is offered for this convention election. We propose that Rita Tyson be able to serve for another 2-year term.

Rationale:

Article VII of the By-Laws state that Nominating Committee members serve 4 years and positions 1, 2 & 3 are elected at one convention, with positions 4 & 5 to be elected at the following convention.

As no convention was held in 2020, this sequence did not happen. To bring the election of the nominating committee members in line with the By-Laws, this motion is presented by the Nominating Committee.

Reports were presented in the Delegates Packets. Several Delegates gave updates on other things that were happening with their Christian Sisters Locals. Many outstanding ideas were presented. Kent Laza (President of the Hus Encampment Board of Trustees) gave a



presentation on the happenings to the update the camp by the Hus Board.

*We were invited to walk around the campus and look at the improvements that have been made.

*Credit was given to the Facilities Manager, Alan Haisler, for keeping the camp looking nice and working properly.

*Thanks was given to the Members of the Hus Board for their "A Team" work. Reverend Joseph Polasek commended the Board Of Trustees for an excellent job.

There were no Correspondence to be read or Unfinished Business. The meeting was adjourned at 12:00 by Paula Wagner and a blessing for the meal was given by Reverend Vanessa Mitchell.

Lunch was from 12:00 to 2:00 (with Committees to meet during this time). A delicious meal consisting of: King Ranch Casserole, Rice, Beans, Salad and Cake was served.

The Second Session of the Convention began at 2:00 with a prayer by President Paula Wagner.

We were able to 'dive' into the Scriptures and share with one another. The kids were given a different perspective of learning with the team members in the classrooms.

The second team arrived two days after the first team left, 10June. They were at New Day for just five days. Each afternoon while the teachers were in a science workshop, the kids were in a basketball camp.

Team Three arrived on the departure

heels of Team Two. This team brought a retreat for the ladies of New Day. It was good just to be able to have a cup of tea or coffee then study God's Word. While the ladies had their retreat, other members of the team taught in the classrooms and others did maintenance projects on the homes and buildings on the property. The team also led a Vacation Bible School in the afternoons. Children from the villages around New Day were invited to come. Team Three left New Day at the end of June. We had almost a week to regroup and get ready for Team Four. During that week, our teenagers came home for a few days from boarding school.

Team Four arrived at New Day on 10July and left on 15July. They had only four days, but it was a packed four days. The team taught in the classrooms, evaluated each child in his/her reading level and rearranged books in the library. Dance and ballet were taught to the girls. Tap dancing was also taught to the younger boys and girls. This team was also able to take a lot of pictures and video many activities. The 'family' pic-

ture was taken for 2022. Also, a group from Choma came out to New Day with their drone and was able to shoot video of New Day from the air. The most exciting part of having this team come to New Day was one of the members. Caedmon Tidwell, the oldest child of Blu and Darbi Tidwell, was a member of this team. All the kids were excited about this. They couldn't wait for Cademon to get to New Day. I had mentioned earlier that the teenagers were home from boarding school. These were the kids that Caedmon grew up with. It was truly a blessing seeing them together, even if it was for just a few days.

Team four left and Team Five arrived. Team five was at New Day for two weeks. They taught in the classrooms and lived with the kids while the staff went to a resort just outside of Munze for a retreat. Munze is a large town about two hours from New Day and is on the way to Lusaka. Team Five left at the end of July. Once again, New Day had a 'breather' before Team Six arrived.

This team was different from the other teams. They were Prosthetic Promises

in His Name. They came to make protheses for people who live I and around New Day area. However, there are some who live several hours away and came to be fitted for a new prosthetic. The team saw 41 patients and made 22 new protheses. The team did involve the older kids. They helped with translating from Tonga to English.

I was not at New Day when Teams Five and Six came. I was able to return to Texas on 15July. I was going to return to Texas on 15July. I was going to return around the 1st of August. However, the cost of and airline ticket made the decision for me to return when I did. I will be returning to New Day around the 1st of March.

Everyone and everything is going well at New Day. The children are growing and thriving. They keep us busy. New Day now has 50 children and teenagers. They range in age from 1 year old to 20 years old. Life is well. God is at work. He continues to bless us every day.

DO SOMETHING: WALK THE WALK (JAMES 2:14) Brethren Youth Fellowship Retreats


The State BYF Leadership Team chose the theme: Do Something-Walk the Walk based mainly on James 2:14 to be the lesson focus for our retreats this year. We need to learn to walk the walk and do something as individuals, learn to love as Jesus loved and live as Jesus lived. We need to learn to walk the walk and do something as the church, come together with hearts ablaze, eyes fixed on Jesus, and turn the world upside down.

We kicked off the year at the September 17-18th retreat with 27 youth and several adults. Our four sessions covered what it means to walk with Jesus. We began with the foundation of our faith, Jesus as the cornerstone, and being built to God's holy temple. Everything we are, and everything we do needs to align with Jesus. Our second lesson was about the discipline it takes to follow Jesus. It requires commitment, action, and time to develop our relationship with God and grow in Him so that we can live for Him.



We also studied what it means to pray and how and when to pray. We need to Praise the holiness of God; Recognize our life is about God's will; Ask for our needs and needs of others; Intentionally let go (of our sin, guilt, anger, control); Strive for goodness; and see that Everything is for God's glory (not ours). In our third session we talked about getting a 'God perspective': My life is about Je-





sus; Jesus is with me; let's go! We need to take Jesus with us, talk to him all day long, and seize every opportunity to learn and grow more in Him. We concluded the weekend evaluating our priorities and the things that prevent us from following God with our whole being. And we were challenged to start making choices to actively seek Jesus and listen to his voice. We were challenged to make choices to be like Jesus, to live like Jesus, and to love like Jesus.

Our November retreat was held on November 5-6. We examined what it means to really walk the walk and not just be a fan of Jesus. We looked at Jesus's trium-



phal entry and the crowd that soon turned on him. We looked at the hypocrisy in the church and with the church leaders. We looked at his closest friends who denied him and ran away to hide after he was arrested. Then we looked at true grace and true mercy throughout the crucifixion story. Jesus knew what was coming; he knew what his closest friends would do, but still he stayed with them; broke bread with them; and continue to teach them. After they denied him and deserted him, he came back to them; he forgave them; he loved them. Even more, he gave his disciples charge to continue his mission and grow the church. We looked at Peter's full restoration and his charge to "Feed My Sheep". Jesus pushes us past our history, past our failures, past our mistakes and pushes us into a desire to live a life that honors him. We were challenged to quit making excuses, get out of our comfort zone, and jump in with a willing heart to follow Jesus and serve Jesus wherever he leads.

The retreats are filled with food, fun, and fellowship. We enjoy crafts, music, sports activities, dominoes, board games, and bingo. In November, we also collected food and supplies for the homeless and made 35 care packages with pop-top soups, chilis, chicken salads, peanut butter, fruits, protein bars, crackers, pon-







chos, and socks. In January, we will be making blankets for shut ins.

If you are a youth ages 12-21, we'd love to have you join us as we continue our journey learning what it means to Do Something- Walk the Walk with Jesus.



GAME: Alike & Unalike

Scripture: "Now you are the body of Christ, and each one of you is a

part of it." 1 Corinthians 12:2

Directions: Give children a direction to group themselves. Examples: Same eye color, Same hair color, number of siblings, favorite color, age, type of shoe, etc. When done, say, "God made us all unique, that means that we are all different. What are some of the things that make us different from one another? Why do you think that God made us all uniquely?" Read Genesis 1:27. God is the Creator of the whole world. He can keep creating more and more things and will never run out of ideas. Human beings are His best creation because He also gave us the ability to think and create new things. We are all created in the image of God but are very different.

OBJECT LESSON: Snow v. Snowstorm

If possible, let students play in real snow or show pictures of individual snowflakes and snow. What do you see? What does the snow feel like? What does it smell like? Say, all of this snow is made up of tiny snowflakes. Look very closely and you will be able to see the tiny flakes. Every snowflake is unique. No two are exactly alike, just like no two people are exactly alike. God made them all unique just like we are unique. But look at what snow can do when all the little flakes stick together.
