Thursday, July 20, 2023 - Registration began at 3:00 p.m. OPENING Session 4:30 p.m. President Rev. Dr. Larry Koslovsky called the 70th Biennial Convention to order and gave an opening prayer.

Welcome & Overview of Convention:

Rev. Koslovsky gave an overview of the convention and welcomed everyone to our time together. He explained that those who are wearing a red lanyard are the official members of the convention and can vote and participate in the meeting. He explained that the bylaw changes and financial decisions we make during the convention require a Referendum vote and will go back to the congregations for approval.

<u>Procedures & Synodical Representative Changes:</u>

Our congregations' Representatives are elected in the fall and serve a 2-year term. There are no substitutes for this person during the term. If you have a new representative, they need to be approved by the Synodical Committee. The following need approval: Joel Mitchell – Caldwell, Jay Zamora – Houston & Kellie Chaplin – Temple

Motion and **Second** to approve new representatives; passes unanimously.

Committee Introductions & Working Agenda:

The 6 committees are: By-Laws/Motions, Finance, Hus Camp, Missions, Brethren Journal/Website, Pastoral Relations. Committee Guidelines were recommended.

The Committees went to their assigned rooms to get started on their tasks.

6:00 Evening Meal - Rev. Koslovs-ky gave the blessing for the meal.

7:30 Worship with Holy Communion:

There were 70 people present at the service. The call to worship was given by Kayla Marek from Psalms 103. Opening prayer by Rev. Vanessa Mitchell in English and Spanish. Music was provided by Myah Collard. The offering was taken up followed by the Doxology; prayer by Rev. Joe Emerson. Lynette Shimek read from Ephesians 3:20-21. Rev. Larry Koslovsky gave the message "More Than Able!" Rev. Koslovsky asked who is this God of Omni's - Omnipotent, Omnipresent and Omniscient. He asked "have we prayed too small? Dreamed too small? Have we settled for a God that's too small? There is so much more to our story – the Lord is not done with us yet; the Lord is more than able!" Holy Communion was administered to all by Rev. James Heil and Rev. Tommy Tal-

8:30 p.m. Pastor to Pastor Selection

Friday, July 21:

9:00 Worship – Attendance – 85. Music provided by Myah Collard on the guitar & singing. The message was given by Pastor Brady Collard – Youth Pastor at Wall Brethren. He spoke about Failure, and how we can expect failure to happen. He read from Mark 9:14-19.

9:30 General Session #1:

There were 90 people in attendance as follows:

58 VOTING MEMBERS present: **Pastors** – 14; **Lay members** – 14; **Delegates** – 28; (28); **Committee Chairs** – 2; and Guests – 32.

Questions on Reports:

Corrections on Christian Sisters report. Kent Laza questioned why we don't have a Treasurers report. Due to a family emergency, everyone was emailed the reports this morning.

Rev. Koslovsky wanted to add a paragraph to the Board of Christian Education report from the Chair – Kari

Raesz, p. 58: "She recommends the disbandment of the Board of Christian Education at the Unity level and continue to have each congregation create and support their own education committee. The lack of Unity support and congregational acceptance leads me to believe this board was just another group created just for looks." It is not functioning like it used to. It was reported that pages 25-26 show what congregations do for Sunday School. There was discussion.

Kent Laza, Chair presented a report on the Hus Encampment. He reported that the camp is doing well; they have spent about \$1-million in the last six years with upgrades to the camp and facilities. The Unity has just purchased 12 acres of land adjacent to the camp with closing on the property to be held next week. The next phase - a new camper dorm for the boys and a family/staff dorm. The approx. cost is \$560K for camper dorm and \$675K for family/staff dorm.

Reports from Congregations: 17 congregations are represented; 6 with no representation (no Representative or Delegate – Buckholts, Dime



Box, Granger, Industry, Seaton, Westheimer). Every congregation had about 3 minutes to give a report.

Retirement of Rev. Thomas Tallas: Rev. Thomas Tallas gave a formal request to retire from active ministry in the Unity of the Brethren and will remain a member at large. (ByLaws Art. III. B. 14) Rev. Tallas gave appreciation for his wife Donna and his family. He was ordained in Granger in 1970; thru the years he has served in a variety of ways.

Motion and **Second** to accept his request to retire (August 31). Passes unanimously. Rev. Hejl led a prayer over Rev. Tallas and Donna.

<u>12:00 Lunch</u> – The Blessing for the meal was given by Rev. Dr. Brad Herridge.

Saturday, July 22: 9:00 Worship – Attendance – 67. Music provided by Kevin & Lynette Shimek – accordion & guitar music and singing. Rev. Groseclose led everyone in singing "Happy Birthday" to Lynette Shimek. Port Arthur folks led Happy Birthday in Spanish. The message was given by Rev. Mike Groseclose. He talked about how much bad news we get. He is reminded about what Paul wrote in Philippians 4:8. The world around us seems bad, but there are good things happening out there.

9:30 Committee Wrap Up:

There were 78 people in attendance as follows:

54 VOTING MEMBERS present: **Pastors** – 10; **Lay members** – 14; **Delegates** -28; Committee Chairs – 2; and 24 Guests.

Rev. Koslovsky opened the meeting. Today, we will finish the By-Law changes.

He first recognized Caroline Groseclose – an unsung heroine. She has spent the last 12 years working with children in Africa. He thanked her for her service and she received a round of applause.

Who are we as the Unity of the Brethren – Rev. Koslovsky asked that we ask this of ourselves and without talking about Jan Hus, being Czech, being Protestant or being like other denominations – we should be able to say, "who we are" in 2 minutes or less. Several reports were given. Joel

In the West, we sanctify our right to privacy. Gospel is about being in each other's lives in a real way – discipleship – in your homes.

Rev. Koslovsky thanked everyone for their thoughts and discussion on this. Now can we do five minutes? Two minutes was the first level. He encouraged everyone to keep this in your thoughts.

10:30 General Session #3

MOTION and SECOND for Article II. Congregations. L: to change percentages of the Contingency Fund from 18% to 9% and Executive Assistant position from 9% to 18% and to keep the Brethren Fund assessment at \$40. Passes. See Referendum report – Item #6.

MOTION and **SECOND** to increase the expense allowance for the Youth Coordinator from \$1,800/yr to \$3,000/yr, an increase of \$1,200.00. Passes. See Referendum report – Item #1.

MOTION and **SECOND** to pay a lump sum payment to Liz Ripple and Jennifer Chervenka in the amount of \$1,000.00 per year for 2023 & 2024. Total cost would be \$4,000.00 to come from Major Gifts. Passes. See Referendum report – Item #2.

MOTION and **SECOND** that the Unity website be redesigned and maintained. Passes. See Referendum report – Item #3.

NEW MOTION and **SECOND** for **Article XI – Treasurer, A & F:**

Passes unanimously. See Referendum report – Item #9.

In regard to proposed Bylaw amendments from the Executive Committee to delete Article XIII – Board of Christian Education, the ByLaws/Motions Committee recommends not to submit these amendments with the understanding there is someone willing to serve as the Chairman of the Board of Christian Education with the intention

of trying to re-engage the board over the next 2 years; if those efforts prove unsuccessful then the next convention can re-visit these items.

MOTION and SECOND that the Unity commit \$600,000.00 toward the construction of a new camper dorm on the campus. These funds are in addition to the funds already paid for the Hlavaty property. The expenditure of these funds shall be managed by the Board of Trustees. Proposed funding source – funds from the sale of Austin Brethren Church.

Bro. Jimmy said after discussion in the ByLaws/Motions committee, there is not a clear consensus on how to present this proposal. 2 options are recommended: Vote on the motion as presented – authorizing \$600,000 for the new dorm in addition to the \$400K plus that has already been allocated for the Hlavaty purchase, bringing that total to over \$1 million. The other option would be a new motion – which needs a Second - to send to the Synodical Committee for further study, evaluation over the next 2 years and then to bring another motion to the next convention. This second option recognizes there are a lot of people who are uncomfortable with such a large expenditure without very much time to consider it at this convention. If the motion passes here, it still needs to go to referendum for all the congregations to vote on. There was discussion on how we can revitalize/help our existing churches. We – the Executive and Synodical Committee - haven't had time to talk about ministry, youth pastors, discipleship for lay people – and how to spend this large amount of money. (Total amount of time spent on this: 1 hour, 8 minutes)

MOTION and SECOND TO AMEND to allow the Synodical Committee the authority to spend up to \$600K on improvements at the camp. Discussion. Several minutes for prayer.

Voting on the amended motion: For – 27; Against – 19; (46 voting) The amendment passes.

VOTE ON MOTION as amended: For – 43; Against – 4. The motion as amended passes. See Referendum re-

port – Item #4.

Motion and **Second** to combine the Foreign and Home Mission Boards and have the First VP as the Chairperson and to have 5 members appointed by the Synodical Committee. Discussion.

Bro. Jimmy said since there would be many amendments needed to bring this change to fruition, he suggests discarding this motion and bring the necessary bylaw amendments to the next convention. The motion was withdrawn.

Motions passed: To come back to Camp Allen for the Convention; to give

the offering of \$575.25 to the Foreign Missionaries; for the convention to dismiss the committees from their duties; to adjourn. Rev. Groseclose gave the blessing for the noon meal. Meeting was adjourned at 12:05.

The End of the Hussite Wars

The Hussite Wars continued. Fourteen years had elapsed since the Defenestration at Prague which ignited the series of conflicts. The Hussite factions agreed on the Four Articles of Prague but disagreed in other matters. Despite this, they remained a formidable military force with which to be reckoned. Sigismund himself was forced to concede that only Bohemians could defeat Bohemians. Cardinal Legate Julian offered that only the upcoming Council at Basle offered any hope in stopping the Hussite movement. In truth, both King and Pontiff were exhausted militarily and still the Hussites prevailed.

Julian traveled to Basle and assumed presidency of this body. He persuaded the Council to invite the Hussites to the deliberations hoping that a peace could be achieved. The Taborites resisted but were eventually won over. A delegation consisting of Utraquists, Taborites, and Orphans was selected. They reached Basle in January 1433 and were welcomed upon arrival.

In an unprecedented event in the history of the established Church, Hussite delegates engaged in dialog. This dialog included the revelation of the sins of the hierarchy, exultations of Jan Hus and Jerome of Prague as bold witnesses for the truth, and defense of the principles

of the Articles of Prague. In May, accompanied by deputies of the Council, the Hussite delegates returned to Bohemia. At Prague, negotiations continued. This resulted in the formation of a second Hussite delegation which traveled to the Council. Council deputies also accompanied this delegation back to Bohemia. What followed was the draft of the Compacta of Basle which substantially conceded the Four Articles. On November 30, 1433, the Compacta was ratified by the Diet.

The Compacta were regarded as the law of the land; and the Utraquist Church was recognized by the Pope as the national self-governing Church of Bohemia. There were basically four terms of the Compacta:

I. Communion was to be given to laymen in both kinds.

II. All mortal sins were to be punished by the proper authorities.

III. The Word of God was to be freely preached by faithful priests and deacons.

IV. No priests were to have any worldly possessions.

For all practical purposes, this agreement meant the defeat of the advanced reforming movement. In truth, the Utraquists had gained one thing and one thing only; they were allowed to take wine at Holy Communion. Aside from this one concession, the Utraquist followers of Hus were in all other respects, Catholic. They adored the Host, read the masses, kept the fasts, and said the prayers as their forebears

had before them.

Also, with the ratification of the Compacta, the fate of the remaining Hussite factions was sealed. The Taborites and Orphans were not completely satisfied and insisted upon additional concessions. Unfortunately for them, their power was declining. Nobility had long grown tired after years of seemingly ceaseless struggle. With prompting by the Utraquists, a league was formed of men of rank with one goal: the pacification of Bohemia and Moravia by overwhelming force.

On May 30, 1434, two armies met at the Battle of Lipany. The Taborites and Orphans were utterly defeated and practically crushed out of existence. The battle became a massacre. The slaughter continued all the night and part of the following day. Prokop the Great and 13,000 of his warriors lay dead in the field. With this battle, the more than 15 years of bloodshed known as the Hussite Wars officially ended.

But there was additional blood to be shed. The last remnants of the Taborites were under the command of Jan Rohac of Dube. This force was besieged at castle Sion near Kutna Hora. It was captured by Sigismund's forces, and on September 9, 1437, Rohac, who still refused to accept Sigismund as his King, was hanged in Prague.

The Utraquists had achieved the goal for which they strove. They were even considered "redeemed" because they abandoned the Taborites at Lipany. They would go on to model themselves on the hierarchy of the Church. They even went as far as to seek Church approval for the appointment of its clergy. After more than 15 years of violent bloodshed, the Hussite movement had been defeated militarily. But with that defeat, several questions remained. Was this to be the end of the reforms Hus strove for? Would the teachings of Hus survive? With the powerful voice of Hus long since silenced and the clamors of war beginning to fade, would a new voice dare to speak out again?



SUNDAY SCHOOL HELPER



Fall is upon us and many children may have experienced or seen the harvesting of crops. Harvest is a powerful Bible concept. More than 100 verses refer to sowing or reaping! This month the activities will revolve around the Parable of the Sower.

The Parable of the Sower

Scripture: Matthew 13:3-9 **Ask** children what a harvest is?

Read Matthew 13:3–9, The Parable of the Sower. As you read, use the Sower's Sack to tell the story.

Sower's Sack Materials: small lunch sack, construction paper, Bi-

ble sticker, marker, scissors, tape, glue.

1. Write Parable of the Sower on the sack.

2. On a light brown strip of paper, write "wayside". Draw little seeds on the paper.

3. Draw a bird on another piece of construction paper.

4. Use another piece of construction paper to make a rock and write "rock" on it.

5. Take a green square of construction paper. "Fringe" it like grass and glue it on top of the rock. This is a withered seed.

6. Use brown paper to create thorns. Write "thorns" on this paper. Glue some small pieces of green to the bottom of the thorns. This is the withered seed.

7. Cut a rectangle from dark brown paper. Cut a small wiggle at the top to resemble a furrow. Cut more grass from dark green construction paper and glue it on top of the dark brown rectangle. Write "good soil" at the bottom. This is good soil.

8. Using dark green paper, cut out a seed. Write "This is a good

seed." Place a Bible sticker or draw a Bible on the seed.

9. Place all the pieces in the sack and use the props as you tell the parable.

A SOWER PLANTED SEEDS Tune: Beverly Hillbillies

A sower planted seeds,
He tossed them all around.
Pesky birds, scorching sun,
Tough thorns and rocky ground,
In good soil, seeds grew tall,
They grew for all to see,
God's Word is the seed,
I'll let it grow in me.



Harvest Game

Materials: balloons, string, large trash bags

Blow up the balloons and tie a string to each one.

Explain that the balloons are giant seeds. The goal is to plant as many seeds as possible.

1. Form two teams. Have children line up on one side, with the

trash bag on the other side.

2. Children must stay on their hands and knees. They will put a string in their mouth and crawl to the garbage bag. They can try to take as many balloons at one time as they think they can handle.

3. Without using their hands, they have to stuff the balloons into the trashbag. (one team member or an assistant can hold open

the bag)

4. Children have 45 seconds to complete the task. At the end of

45 seconds, say STOP.

5. Then the next two children try. Continue until everyone has a chance. The team with the most seeds in the bag, wins.

Talk about how many seeds didn't get planted (make it in the bag). Connect that to the Parable of the Sower. Talk about what happened to the ones that didn't grow. **Read** Matthew 18–23. Use the balloon seeds as an illustration.

Jesus said the seeds are like the Good News about God.

• When anyone hears and does not understand, the evil one snatches away what was sown in their heart. This is the seed sown along the path.

• The seed falling on rocky ground refers to someone who hears the word and receives it with joy. But since they have no root,

they last only a brief time.


• The seed Falling in the thorns refers to someone who hears the

word, but the worries of this life make it unfruitful.

• Pick up the garbage bags with the balloons. These are the good seeds! These are like the people that heard the word of God when it was sown to them in spiritual seeds.
